that the said disease is highly dangerons to the health of His Majesty's subjects, and may be brought into the United Kingdom, or the islands of Guernsey, Jersey, Alderney, Sark, or Man, by vessels coming from, or having touched at, certain ports or places of the Continent of Europe, which are hereinafter more particularly described, either with or without clean bills of health ; and His Majesty is therefore pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that ell vessels coming from, or having touched at, any port or place in Russia, or any port or place in the Baltic, or in the Cattegat Sea, or any port or place on the Elbe, and bound to any port or place in the United Kingdom, or to the islands of Guernsey, Jersey, Alderney, Sark, or Man (having clean bills of health), as well as all vessels, boats, and persons having had communication with such vessels, shall proceed to such of the under-mentioned ports as may be the nearest and most convenient to their port of destination, viz. Cromarty-bay, in the Murray Frith, to the anchorage in the Frith of Tay, near Dundee, in the Frith of Forth, between the North Queen's-ferry and Lord Elgin's Lime-kilns; White Booth-roads, (between Hull and Grimsby); Standgate-creek ; the Motherbank, at Portsmouth ; Plymouth ; Falmouth ; Milford-haven ; Bromboro'pool (in the river Mersey, near Liverpool); Holyloch, in the Frith of Clyde; and all vessels arriving with foul bills of health, or coming (without bills of health) from any port or place where the cholera is known to prevail, shall proceed either to Cromarty-bay, in the Murray Frith, to Standgate-creek or to Milford-haven, and shall there perform quarantine, and be subject, with their crews, pilots, and all persons having communication with such vessels, to all the rules and regulations established by His late Majesty's Order in Council, of the nineteenth of July one thousand eight hundred and twenty-five :

And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors and Commanders in Chief for the time being of the said isles of Guernsey, Jersey, Alderney, Sark and Man, are to give the necessary directions herein as to them may respectively appertain.

A Chapter of the Most Noble Order of the Garter having been summoned this day, the following Knights Companions, in their mantles and collars, assembled in the Entreé-room, viz.

Their Royal Highnesses the Dukes of Cumberland, Sussex, and Gloucester, the Earl of Westmorland, the Marquess Camden, the Earl of Hardwicke, the Duke of Beaufort, the Earl of Lonsdale, the Marquess Wellesley, the Duke of Montrose, the Earl Bathurst, the Duke of Northumberland, the Marquess of Hertford, the Duke of Dorset, the Duke of Devonshire, the Duke of Richmond, the Duke of Bedford, and Earl Grey, attended by the under named Officers of the Order, in their mantles, chains, and badges, viz. the Lord Bishop of Winchester, Prelate of the Order; it he Honourable and Reverend the Dean of Windsor, Register of the Order; Sir George Nayler, Knt. Garter Principal King of Arms; and Sir Thomas Tyrwhitt, Knt. Gentleman Usher of the Black Rod.

At half past three o'clock the Knights Companions were called over by Garter, and, with the Officers of the Order, proceeded into the presence of the Sovereign in the Throne-room.

The Sovereign being seated on the Throne, and the Knights Companions having taken their respective places, the Prelate of the Order, by His Majesty's command, signified to the Chapter the Sovereign's royal will and pleasure that a lineal descendant of His Majesty King George the Second should, in pursuance of the statute in that behalf made, be elected into the said Most Noble Order.

The Knights Companions then proceeded to the election, and the suffrages having been collected by the Prelate, were by his Lordship presented to the Sövereign, who was pleased to command him to declare, and he accordingly declared, that His Serene Highness Augustus-William-Maximilian-Frederick-Lewis, Reigning Duke of Brunswick had been duly elected a Knight of the Most Noble Order of the Garter.

The Duke of Brunswick was thereupon conducted from the private apartment of the Sovereign into the Chapter-room, between their Royal Highnesses the Dukes of Cumberland and Sussex, the two senior Knights Companions, preceded by Garter (bearing the ensigns of the Order upon a crimson velvet cushion), and by Black Rod.

On entering the Chapter-room, His Serene Highness was received by the Sovereign and Knights Companions standing, and placed in a chair of state on the right hand of the Sovereign.

His Majesty was then graciously pleased to announce to the Duke of Brunswick, that His Serene Highness had been duly elected a Knight of the Most Noble Order of the Garter.

Garter, upon his knee, presenting the Garter to the Sovereign, His Majesty, assisted by their Royal Highnesses the Dukes of Cumberland and Sussex, buckled it on the left leg of His Serene Highness, the Prelate pronouncing the usual admonition. Garter next presented, in like manner, the ribband

Garter next presented, in like manner, the ribband with the George, and the Sovereign, assisted as before, put the same over the shoulder of the Duke of Brunswick, the Prelate pronouncing the admonition.
