undersigned humbly conceive that when urgent circunistances render it desirable for any small number of persons to submit to a voluntary sacrifice for the public good, it should be readily and cheerfully made; for the undersigned persuade themselves that if it he, as a celebrated Roman author has justly observed, " gratifying and decorous to die for one's country," every true patriot is assuredly bound to set aside all selfish objects upon any question deeply affecting the welfare of his fellow-countrymen.

These being the genuine sentiments of the undersigned, they most respectfully beg to declare to your Majesty, that considering the borough of Tregonycont ins but a comparatively very small body of electors, and that the people of England seem, for the most part, to wish and expect that members to serve in the Commons' House of Parliament should be elected by much larger bodies of the community, the undersigned are anxious, ready, and willing to yield up and resign, of their own free will and accord, their ancient rights and privileges as electors and free burgesses of Tregony, in favour of any large city or populous district, should their example induce the remainder of the electors (as the undersigned trust and believe would eventually be the case) ro join them in such an act, and provided such resignation should be deemed by your Majesty in Council as likely to be productive of national benefit.

In presuming to offer this humble but independent Address to the beloved and patriotic King of a mighty nation, the undersigned venture to entertain the sincere hope that their example may be followed by other small boroughs similarly situated, and that the tender of such voluntary sacrifices for the general good may happily supercede the necessity of any strong measures being resorted to for, or against, a reform in Parliament, liable to be considerered, on the one hand, as an inroad on the constitution, or, on the other, as an obstinate resistance to the general

wishes of the people.

With the sincerest feelings of respect and affectionate regard for your Majesty's Royal Person and Family, and the earnest prayer that your Majesty and your amiable and illustrious Consort Queen Adelaide, may long live and reign over a faithful, grateful, and united people, the undersigned subscribe themselves, Sire, your Majesty's ever loyal, attached and devoted subjects.
