The following Addresses were this day presented to His Majesty at the Levee, and graciously received:

From the Inhabitants and Freeholders of the county of Westmeath, in Ireland, in county meeting assembled, convened by the High Sheriff, and signed by the Chairman and the Secretary, in favour of Parliamentary Reform.

From the Gentry, Clergy, Freeholders, and others, whose names are signed, of the hundred of Lonsdale, North and South of the Sands, in the county palatine of Lancaster, against Reform and the Creation of new Peers.

Westminster; April 3, 1832.

This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several office Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for granting to His Majesty, until the tenth day of October one thousand eight hundred and thirty-two, certain duties ou sugar imported into the United Kingdom, for the service of the year one thousand eight hundred and thirty-two.

An Act to amend several Acts, relating ito London-bridge and the approaches thereto.

An Act for making and maintaining a reservoir upon Bradshaw brook, in the townships of Eurton and Entwisle, in the parish of Bolton-le-Moors, in the county of Lancaster, for providing a more regular supply of water in Bradshaw-brook aforesaid, and in certain rivers connected therewith.

An Act for better supplying with water the borough of Preston, and part of the township of Fishwick adjoining thereto, in the parish of Preston, in the county palatine of Lancaster.
