*Whitehall, October 23, 1834.*

**T**HIS day being appointed for the further prorogation of Parliament by Commission, and His Majesty having been graciously pleased, under the circumstances of the calamitous destruction of both Houses of Parliament by fire, to signify His Royal commands to the Marquess of Cholmondeley, Deputy Great Chamberlain of England, touching the places of meeting for that purpose, the Lords Commissioners (consisting of the Lord High Chancellor, the Lord Privy Seal, and the Lord Auckland) assembled at two o'clock, in the room heretofore appropriated as the Library of the House of Lords; the Commons being assembled in a Committee-room contiguous thereto. Sir Augustus Clifford, Gentleman Usher of the Black Rod, was directed by the Lord Chancellor to desire the immediate attendance of the Commons in the usual course; and the Commons being come thither, the Commission was read by the Clerk, and the Lord Chancellor signified to both Houses His Majesty's royal will and pleasure, that the Parliament should be further prorogued to Tuesday the twenty-fifth of November next, to be then and there holden, and the Parliament was prorogued accordingly.

44th Foot, Lieutenant John Edward Codd to be Adjutant, vice Gray, who resigns the Adjutantcy only. Dated 28th March 1834.

43th Foot, James William Graves, Gent. to be Ensign, without purchase, vice Campbell, promoted in the 41st Regiment of Foot. Dated 24th October 1834.

69th Foot, Staff-Assistant-Surgeon Robinson Turner to be Assistant-Surgeon, vice Fisher, whose appointment has not taken place. Dated 24th October 1834.
