Charence and Hartlepool Union Railway, and Asylum Harbour.

NOTICE is hereby given, that, application is intended to be made to Parliament in the next session, (for which notice was, given in November 1836, and in February and March last,) for leave to bring in a Bill, to be passed into an Act, for the making of a railway or railways, with all proper works and conveniences attached thereto, for the passing of waggons, carriages, and locomotive engines; which said railway or railways will commence at or near to the Three-and-a-quarter Milepost placed by the side of the Clarence Railway, and adjoin, enter into, and communicate with the Clarence Railway situate in the township and parish of Billingham, and extend to, pass over, through, or into the several townships, hamlets, or places of Billingham, Wolviston, Coopen Bewley, Newton

Bewley, Greatham Hospital (which is extra pury-chial), Greatham Bast Hield, Seaton Chrew, Stan-ton, Hart, and Throston, and upto the parishes of Billingham, Greatham, Stranton, and Hart, all in the county of Durham; that it is intended to deviate the aforesaid line of railway at and from a field, number 15 on the plan, occupied by Mary Stonehouse, in the township of Greatham Hospital and parish of Greatham, which deviation will pass through, over, or into the townships of Greatham Hospital (which is extra parochial), Greatham.
