**W**HEREAS the Chairman of the Select Committee appointed by the House of Commons, to try and determine the merits of the petition of John Faunt and others, electors, complaining of an undue election and return for the county of Westmeath, did, on the 7th day of June 1838, inform the House, that the said Select Committee had made an order for the nomination and appointment of Commissioners to examine evidence in Ireland respecting certain facts, allegations, matters, and things referred to the said Commissioners, and specially assigned and limited in the said order;

And whereas I have this day received a copy of the minutes of the proceedings of the said Commissioners under their hands and seals;

Now I do hereby and by virtue of an Act, passed in the 42d Geo. 3, intituled "An Act for regulating the trial of controverted elections or returns of Members to serve in the United Parliament for Ireland," direct the aforesaid Select Committee to re-assemble and meet upon the second Tuesday after the first day of the next session of Parliament, at twelve o'clock at noon, to take the proceedings of the said Commissioners into consideration.

For which this shall be to the aforesaid Select Committee a sufficient warrant.
