*London and Blackwall Railway.*

**W**HEREAS the London and Blackwall Railway Company, under their Act of Parliament, passed in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for making a railway from the Minories to Blackwall, with branches, to be called 'The Commercial Railway,'" and of another Act, passed in the second and third years of the reign of Her present Majesty, intituled "An Act for extending the line of the railway between London and Blackwall, called the Commercial Railway, and for amending the Acts relating thereto," are authorised and required to contract for and to sell such superfluous lands as might be purchased by the said Company, or any estate or interest in such lands, first offering to sell the same to the person, or to the several persons, whose lands or premises shall immediately adjoin the lands so proposed to be sold, by notice, to be inserted twice in the London Gazette, and twice in two London newspapers; now the said Company do hereby give notice, that they propose immediately to sell and dispose of the superfluous lands mentioned in the schedule hereto, and more particularly described in a plan, which may be seen at the office of the Company, at No. 62, Moorgate-street, London; and they do therefore hereby first offer to sell the same lands to the person, or to the several persons, whose lands or premises immediately adjoin the lands so proposed to be sold, for such price or prices as may be agreed upon between such

**N**OTICE is hereby given, that application is intended to be made to Parliament in the next session, for an Act to alter, amend, and enlarge the powers and provisions of an Act of Parliament, passed in the second year of the reign of King George the Third, intituled "An Act for the enlightening the streets, lanes, and passages within the town and county of the town of Nottingham;" and also of an Act of Parliament, passed in the session of Parliament holden in the first and second years of the reign of King George the Fourth, intituled "An Act to alter, amend, and enlarge the powers of an Act, of the second year of His late Majesty's reign, intituled 'An Act for the enlightening the streets, lanes, and passages within the town and county of the town of Nottingham;'" or to repeal the said recited Acts, and to grant further and other powers and provisions in lieu thereof.

And that it is also proposed and intended to take powers by the said Act to raise money for paying off the debts occasioned by the insufficiency of the existing rates and assessments authorised by the said recited Acts for the purposes of the said Acts, and to alter such existing rates and assessments; and otherwise to make provisions for raising money sufficient for the purposes aforesaid, and for fully and efficiently lighting the streets, lanes, and passages, within the town and county of the town of Nottingham aforesaid.—Dated this 10th day of October 1839.
