opinion that the Legislature could not have intended to invest the Secret Committee, under the direction of the President of the Board of Control, with the unconstitutional power of disbursing such funds to an unlimited extent, and that such disbursements ought to be subject to the approval of the Court of Directors; this Court, therefore, recommends the Court of Directors to adopt such measures as may be necessary to ascertain the state of the law on this important question, with the view of petitioning Parliament to define such power, and to place it under constitutional control.

The said Court of Directors do likewise give notice' that another Proprietor has intimated his intention to submit the following motion, at the said Quarterly General Court, viz.

" That this Court do take into consideration the communications of two missionaries, recently arrived from India, which were made at the public meetings of the Wesleyan Missionary Society, held in London on the days of the 4th and 18th May last, together with two letters, which were addressed to the Court of Directors, in consequence, by Mr. John Poynder, one of the Proprietors of this Company, dated the 11th and 28th May last, and also the official answer of the Secretary to such letters, dated the 2d June last.
