the Curtain-road, opposite to Chapel-street; and | then to proceed southward along the centre of the Curtain-road, including the west side thereof to Worship-street; then eastward along the centre of Worship-street, including the south side thereof to the boundary line between the parish of Saint Leonard, Shoreditch, and the liberty of Norton Falgate; then proceeding southward along the boundary line between St. Leonard, Shoreditch, and Norton Falgate, and Saint Botolph, Bishopsgate, to Eldon street; then westward along the boundary line between Saint Leonard's, Shoreditch, and Saint Stephen, Coleman street, to the boundary stone of the parishes of Saint Leonard, Shoreditch, and Saint Stephen, Coleman-street, and Saint Luke, Middlesex; then proceeding northward along the boundary line between St. Leonard, Shoreditch, and Saint Luke, Middlesex, to the common sewer which crosses Paulstreet, between the houses' numbered 26 and 27 on the one side, and 90 and 91 on the other side; then proceeding eastward along the common sewer, including the south side thereof, to New North-place; then southward along the centre of New Northplace, including the west side thereof, to the centre of Chapel-street; then eastward along the centre of Chapel-street, including the south side thereof, to the centre of the Curtain-road, where the boundary commenced, as the same are more particularly delineated in the plan hereunto annexed, and therein coloured

"That the boundaries of the district of Christchurch, Hoxton, should be as follow:

"The boundary line to commence in the centre of the road, opposite to Mr. Warburton's house, in the boundary line which separates the parishes of Saint Leonard, Shoreditch, and Saint John, at Hackney, near the Canal-bridge in the Whitmore-road, proceeding southward over the bridge, along the centre of the said road, including the west side thereof, to the end of Hoxton Old-town, opposite to Hydeplace; then continuing first in a curved line in a south eastern direction; thence southerly along the centre of Hoxton Old-town, including the west side thereof, to Hemsworth-street; then west along the centre of Hemsworth-street, including the north side thereof, and proceeding in the same direction across Whitmore place, along the centre of an in-tended street, including the north side thereof, to Rempstone-place; then along the centre of Rempstone-place, including the north side thereof; then crossing the New North-road, and continuing westward along the centre of Cavendish street, including the north side thereof, to the intended street, running nearly north and south in the same line with Provoststreet; then proceeding northward along the centre of the intended street, including the east side thereof, to the Eagle Wharf-road; then continuing in the same direction along the open sewer to the boundary line between the parishes of Saint Leonard, Shoreditch, and Saint Mary, Islington; then proceeding easterly along the boundary line which separates Saint Leonard's, Shoreditch, from Saint Mary, Islington, and Saint John, at Hackney, as far as the centre of the road, opposite to Mr. Warburton's house, near the Canal-bridge, where the boundary commenced, as the same are more particularly deli-

neated in the plan hereunto annexed, and therein coloured green.

"That marriages, baptisms, churchings, and burials should be performed in the said chapel, called St. James's Chapel; and that the whole of the fees arising therefrom should be received by and belong to the Minister of the said chapel, called St. James's Chapel:

"That marriages, churchings, and baptisms should be performed in the said chapel, called Christchurch Chapel:

"That the consent of the Lord Bishop of London has been obtained thereto, as required by the above-mentioned section of the said Act, passed in the 59th year of His Majestv King George the Third; in testimony of which the said Lord Bishop has signed and sealed this present instrument:

"Your Majesty's Commissioners, therefore, heg leave to lay before your Majesty the above-mentioned circumstances, and humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation together with the plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made and effected, agreeably to the provisions of the said Acts.
