THE following Addresses were presented to the Queen by the Right Honourable Sir James Graham, Bart. Secretary of State for the Home Department, and were very graciously received by Her Majesty:

To the QUEEN's Most Excellent Majesty.

WE, your Majesty's most faithful and loyal subjects, the Noblemen, Deputy Lieutenants, Landholders, Commissioners of Supply, and Justices of Peace of the county of Aberdeen, in general meeting assembled, beg leave to approach the Throne with an expression of our unfeigned indignation and abhorrence at the late most atrocious and treasonable attempt against the sacred life and person of your Majesty, and our heartfelt congratulations on your Majesty's happy preservation.

Under a deep feeling of thankfulness for the merciful interposition of Divine Providence, which has been manifested upon this occasion, we would renew our assurances of devoted attachment and loyalty to your Majesty, and our earnest prayer to Almighty God that your Majesty may long be spared to reign in peace and prosperity over this great empire.
