"Your Majesty's Commissioners, therefore, beg leave to lay before your Majesty the beforementioned circumstances, and humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation into consideration, is pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignments be made, and that the recommendation of the said Commissioners in respect to the solemnization and performance of baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts.
