Westminster, March 3, 1843.

THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to enable Her Majesty to indemnify the holders of certain forged Exchequer Bills.

An Act to discontinue certain actions, under the provisions of an Act of the second year of King William the Fourth, for regulating the vend and delivery of coals in the citics of London and Westminster, and in certain parts of the adjacent counties.

THE following is a copy of an Order of Her Majesty in Council, assigning chapelry districts to the chapels of St. David, at Holmebridge; Christ. Church, at Linthwaite; Trinity Church, at South Crosland; Emmanuel Church, at Lockwood; and All Saints, at Netherthong, in the parish of Almondbury, in the county of York, under the 16th section of the 59th Geo 3., cap. 134:

At the Court at Windsor, the 10th of December 1842, present, the Queen's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fiftyeighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all
