NOTICE is hereby given, that a Bill is now pending in the House of Commons, entitled "A Bill to alter and amend certain provisions of the Acts relating to the docks and harbour of Liverpool;" and that, by such Bill, it is proposed to repeal and amend so much and such parts of the said Acts, passed, respectively, in the eighth year of the reign of Queen Anne, the third year of the reign of King George the First, the eleventh year of the reign of King George the Second, the second, twenty-fifth, thirty-ninth, fifty-first, fifty-third, and fifty-ninth years of the reign of King George the Third, respectively, the sixth and the ninth years of the reign of King George the Fourth, respectively, the session of the eleventh year of the said last-mentioned reign, and of the first year of the reign of King William the Fourth, and in the fourth year of the reign of Her present Majesty, or of such of the said Acts as relate in any manner to the mode of ascertaining the tonnage and admeasurement of vessels liable to the payment of tonnage rates and duties to the trustees of the said docks.
