THE following is a copy of an Order of Her Majesty in Council, assigning a chapelry district, under the 16th section of the 59th Geo. 3., cap. 134, to Saint Mary's Chapel, at Muker, in the parish of Grinton, in the county of York:

At the Court at Buckingham-Palace, the 23d of August 1843, present, the Queen's Most Excellent Majesty in Council.
