A T the Court at Buckingham-Palace, the 17th day of April 1844, PRESENT.

The QUEEN's Most Excellent Majesty in Council.

TATHEREAS by a certain Act of Parliament, ; made and passed in the session of Parliament holden in the sixth and seventh years of Her Majesty's reign, intituled "An Act for the better " government of Her Majesty's subjects resorting " to China," it is, amongst other things, enacted, that it shall be lawful for Her Majesty, by any Order or Orders made, with the advice of Her Majesty's Privy Council, to ordain for the government of Her Majesty's subjects, being within the dominions of the Emperor of China, or being within any ship or vessel at a distance of not more than one hundred miles from the coast of China, any law or ordinance which to Her Majesty in Council may seem meet, as fully and effectually as any such law or ordinance could be made by Her Majesty in Council for the government of Her Majesty's subjects being within the island of Hong Kong:

And whereas by a certain other Act of Parliament, made and passed in the session of Parliament holden as aforesaid, intituled "An Act to remove "doubts as to the exercise of power and juris-"diction by Her Majesty within divers countries "and places out of Her Majesty's dominions, and "to render the same more effectual," it is, amongst

other things, enacted, that it is and shall be lawful for Her Majesty to hold, exercise, and enjoy any power or jurisdiction which Her Majesty now hath, or may at any time hereafter have, within any country or place out of Her Majesty's dominions, in the same and as ample a manner as if Her Majesty had acquired such power or jurisdiction by the cession or conquest of territory:

And whereas Her Majesty hath power and jurisdiction in the dominions of the Emperor of China; now, therefore, in pursuance of the above recited Acts, or either of them, Her Majesty is pleased, by and with the advice of Her Privy Council, to order, and is hereby ordered, that Her Majesty's Consuls and Vice-Consuls resident within the said dominions, or such other persons, as by warrant under the hand and seal of the Chief Superintendent of the trade of Her Majesty's subjects in China for the time being, shall be appointed to act provisionally as Consuls or Vice-Consuls. shall severally, in the districts within which they may respectively be appointed to reside, have and hold all necessary power and authority to exercise jurisdiction over British subjects within such districts as aforesaid, for the repression and punishment of crimes and offences by them committed within the dominions of the Emperor of China, and for the arrangement and settlement of all and all manner of differences, contentions, suits, and variances that may or shall happen to arise between them, or any of them; and shall moreover have

power and authority, as far as in them lies, to compose and settle all and all manner of differences, contentions, suits, and variances that may or shall happen to arise between British subjects and the subjects of the Emperor of China, and between British subjects and the subjects of any foreign power, and which may be brought before them for settlement:

And whereas, by the above first recited Act, it is enacted, that it shall be lawful for Her Majesty, by any commission or commissions under the Great Seal of the United Kingdom, or by any instructions under Her Majesty's signet and sign manual accompanying and referred to in any such commission or commissions, to authorize the Superintendent of the trade of Her Majesty's subjects in China (so long as such Superintendent shall be also Governor of the island of Hong Kong) to enact, with the advice of the Legislative Council of the said island of Hong Kong, all such laws and ordinances as may from time to time be required for the peace, order, and good government of Her Majesty's subjects, being within the dominions of the Emperor of China, or being within any ship or vessel at a distance of not more than one hundred miles from the coast of China, and to enforce the execution of such laws and ordinances by such penalties and forfeitures as to him, by the advice aforesaid, shall seem fit; and whereas Her Majesty has been pleased to grant such commission as aforesaid to John Francis Davis, Esq. appointed by Her Majesty Superintendent of the trade of Her subjects in China, or the Superintendent for the time being of such trade:

Now, therefore, Her Majesty is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, that Her Majesty's Consuls and Vice-Consuls in China, or any persons acting provisionally as such Consuls or Vice-Consuls as aforesaid, shall, in the exercise of the jurisdiction granted unto them by this present Order, be governed by such laws and ordinances in that behalf as may be enacted in the manner and form aforesaid by the Superintendent of the trade of Her Majesty's subjects in China for the time being, being the Governor of Hong Kong; and in further exercise of the powers in Her Majesty vested by the above-recited Act, for " removing doubts as to the exercise of power " and jurisdiction by Her Majesty within divers

" places out of Her dominions, and for rendering the same more effectual," Her Majesty is pleased, by and with the advice of Her Privy Council, to appoint the colony of Hong Kong as the British colony wherein crimes and offences committed by British subjects within the dominions of the Emperor of China, which it may be expedient should be inquired of, tried, determined, and punished within Her Majesty's dominions, shall be so inquired of, tried, determined, and punished, and that Her Majesty's Consuls, Vice-Consuls, or other persons provisionally acting as such, under warrant from the Chief Superintendent of British trade in China as aforesaid, shall have authority to cause any British subject, charged with the commission of any crime or offence the cognizance whereof may at any time appertain to them, or any of them, to be sent for trial to the said colony of Hong Kong; and it is further ordered, that the Chief Justice of the colony of Hong Kong for the time being, or other person provisionally acting as such, shall, when duly required by the said Superintendent, proceed to the dominions of the Emperor of China, and shall have power and authority, within the said dominions, to inquire of, try, determine, and punish any crimes or offences committed by British subjects within the said dominions :

And the Right Honourable the Earl of Aberdeen, and the Right Honourable Lord Stanley, two of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein as to them may respectively appertain.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with "certain modifications, the fourth report of "the Commissioners of Ecclesiastical Duties and "Revenues;" duly prepared and laid before Her Majesty in Council a scheme, bearing date the twelfth day of March one thousand eight hundred and forty-four, in the words and figures following, that is to say: "We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry into effect, with certain modi-"fications, the fourth report of the Commissioners "of Ecclesiastical Duties and Revenues;" have prepared, and now humbly lay before your Majesty in Council, the following scheme, for uniting the sinecure rectory of Duloe, in the county of Cornwall, and in the diocese of Exeter, with the vicarage of Duloe, in the same county and diocese.

"Whereas by the said Act it is enacted, that, with respect to any benefice with cure of souls which is held together with, or in the patronage of, the holder of any prebend or other sinecure preferment belonging to any college in either of the Universities, arrangements may be made, by the authority therein provided, and with the consents of the respective patrons, for permanently uniting such preferment with such benefice :

"And whereas there is in the said county of Cornwall and diocese of Exeter a vicarage, being a benefice with cure of souls within the meaning of the said recited Act, called or known by the name of the Vicarage of Duloe; and there is also in the same county and diocese a sinecure rectory, being a sinecure preferment, also within the meaning of the same Act, called or known by the name of the Rectory of Duloe :

"And whereas the said vicarage is now held by the Reverend Robert Scott, Clerk, together with the said sinecure rectory, and the Master and Fellows of Balliol College, in the University of Oxford, are patrons, as well of such vicarage as of such sinecure rectory :

"And whereas application has been made to us to make arrangements for the union of the said sinecure rectory with the said vicarage, and it appears to us to be expedient that such union should be forthwith effected, and that such other arrangements relating thereto should be made, as are hereinafter mentioned :

" Now, therefore, we humbly recommend and propose, with the consent of the said Master and Fellows of the said College of Balliol, in testimony whereof they have affixed their corporate seal hereto, that the said rectory and vicarage of Duloe shall be forthwith permanently united and consolidated, and the same shall become and be one benefice with cure of souls, by the name of the Rectory of Duloe; and that the said Robert Scott shall thereupon become and be Rector of such rectory, and he and his successors, Rectors of the same rectory, shall be entitled to all the emoluments both of the said sinecure rectory and of the said vicarage, and that the rectory of Duloe shall, after such union as aforesaid, be in the patronage of the Master and Fellows of the said College of Balliol for ever.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other

measures relating to the said rectory of Duloe, in conformity with the provisions of the said recited Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Exeter.

THEREAS the Ecclesiastical Commissioners  $\bigvee$  for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled An Act for carrying into effect the reports of " the Commissioners appointed to consider the state of the Established Church in England and Wales, with reference to ecclesiastical duties " and revenues, so far as they relate to episcopal " dioceses, revenues, and patronage;" and of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled " An Act to carry into effect, with " certain modifications, the fourth report of the "Commissioners of Ecclesiastical Duties and "Revenues;" and of another Act, passed in the session of Parliament held in the fifth and sixth years of Her Majesty's reign, initial and sixth "Act to alter and amend the law relating to "ecclesiastical houses of residence," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-third day of January one thousand eight hundred and forty-four, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for "carrying into effect the reports of the Com-"missioners appointed to consider the state of "the Established Church in England and Wales, "with reference to ecclesiastical duties and re-"venues, so far as they relate to episcopal dioceses, "revenues, and patronage;" and of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry into effect, with certain modi-"fications, the fourth report of the Commissioners " of Ecclesiastical Duties and Revenues;" and of another Act, passed in the session of Parliament held in the fifth and sixth years of your Majesty's reign, intituled "An Act to alter and amend the " law relating to ecclesiastical houses of resi-" dence," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for authorising the application of certain monies, and a sale of certain stock belonging to the Dean and Chapter of Worcester, and for enabling the said Dean and Chapter to purchase therewith certain premises near the cathedral church of Worcester, for the improvement of the precincts thereof.

"Whereas by the secondly-recited Act it is enacted, that, by the authority therein provided, and for the purpose of fully carrying into effect any of the provisions thereof, any sum of money which shall have been invested in the public funds, or in other security or securities, in trust, for any ecclesiastical body corporate, aggregate or sole, may, upon an application, in writing, to us, under the hand and seal of such body corporate, and in case of any chapter, with the consent of the visitor thereof, be directed to be sold, and the same shall be sold accordingly, and the produce of such sale shall be applied to such purpose and in such manner as shall appear most conducive to the permanent benefit of such body corporate :

" And whereas by the thirdly-recited Act it is enacted, that it shall be lawful for the dean and chapter of any cathedral church, under the authority provided in the herein first-recited Act, to purchase any house or site, being contiguous or near to such cathedral church, and to add to, alter, or improve any such house, or to take down the same, and to build another house, or more houses than one, upon the site thereof, or to apply the site of any such house, or any part thereof, by and with the authority aforesaid, to the improvement of the cathedral or the precincts thereof:

"And whereas by the same Act it is declared and enacted, that the provisions of the said secondly-recited Act, relating to the sale and application of any sum of money invested in trust for any ecclesiastical body corporate, do and shall include and apply to all monies and securities for money, and to all stock in the Government Funds, or elsewhere, standing in the name of the Accountant-General of the Court of Chancery, or in the name or names of any other public officer, or of any individual or individuals, for or to the credit or for the benefit of or in trust for any dean and chapter, whether for the purpose of being laid out in land or otherwise; and that the same provisions shall extend and may be applied to any of the purposes of the Act now in recital:

"And whereas the sum of four hundred and fifty-eight pounds, being the amount of the purchase moncy of certain lands in the parishes of Bredicot and Tibberton, in the county of Worcester, sold by the said Dean and Chapter to the Birmingham and Gloucester Railway Company, under the authority of an Act, passed in the session of Parliament held in the sixth year of the reign of His said late Majesty, intituled "An

"Act for making a railway from Birmingham to "Gloucester, with a branch therefrom," has been paid by the said Company into the Bank of England, in the name and with the privity of the Accountant-General of the Court of Chancery, and placed to his account there:

"And whereas certain other sums of money, amounting together to the sum of two hundred and seventy pounds, the purchase moneys of certain other lands sold by the said Dean and Chapter to the said Company, in the parishes of Stoke Prior and Himbleton, in the said county of Worcester, have been, under the authority of the same Act, paid to Edmund Hungerford Lechmere, of Great Malvern, in the county of Worcester, Esquire, and John Whitmore Isaac, of Boughton, in the parish of Saint John in Bedwardine, in the said county of Worcester, Esquire, as Trustees for the said Dean and Chapter :

"And whereas certain other sums of money, being the purchase monies of lands sold by the said Dean and Chapter to the Stratford and Moreton Railway Company, under the authority of an Act, passed in the session of Parliament held in the first and second years of the reign of His Majesty King George the Fourth, intituled "An Act for " making and maintaining a railway or tramroad " from Stratford-upon-Avon, in the county of " Warwick, to Moreton in Marsh, in the county " of Gloucester, with a branch to Shipston-upon-" Stour, in the county of Worcester;" and of another Act, passed in the session of Parliament held in the third year of His late Majesty King William the Fourth, intituled "An Act for " enabling the Stratford and Moreton Railway " Company to make a new branch of railway to "Shipston-upon-Stour, in the county of Wor-" cester," have been also paid to the said Edmund Hungerford Lechmere and John Whitmore Isaac, as Trustees for the said Dean and Chapter, and have been invested in their names in the purchase of one hundred and twenty-two pounds seven shillings and five pence Three per Cent. Consolidated Bank Annuities, and the dividends thereof have been, from time to time, paid to the said Dean and Chapter, in accordance with the provisions of the same Acts :

"And whereas the said Dean and Chapter are entitled, subject to a certain lease, bearing date the first day of December one thousand eight hundred and thirty-one, and made between the said Dean and Chapter, of the one part, and Ann Wylde, widow, of the other part, to the fee simple and inheritance of and in the dwelling-house, garden, and premises decribed in the schedule hereunto annexed, which dwelling-house and premises were, by the said indenture of lease, demised to the said Ann Wylde for the term of forty years from the twenty-fifth day of November next before the making thereof, and the residue of the said term is now vested in Edward Oldnall, of the city of Worcester, Gentleman:

Birmingham and Gloucester Railway Company, under the authority of an Act, passed in the session of Parliament held in the sixth year of the reign of His said late Majesty, intituled "An to us by the said Dean and Chapter, and it appears to us, that it will be most conducive to the ( permanent benefit of the said Dean and Chapter, and to the improvement of the said cathedral church and the precincts thereof, that all the estate and interest of the present lessee in the said dwelling-house and premises should be forthwith purchased by the said Dean and Chapter, and to that end that the said sums of four hundred and fifty-eight pounds, and two hundred and seventy pounds sterling, and the produce of so much of the said sum of one hundred and twenty-two pounds seven shillings and five pence Three per Cent. Consolidated Bank Annuities, as shall be necessary for that purpose, should be applied by the said Dean and Chapter in the purchase of such leasehold estate as aforesaid, and that the said Dean and Chapter should thereupon be empowered to apply such premises to the purposes hereinafter mentioned; and an application, accordingly, has been duly made to us, in writing, by the said Dean and Chapter:

"Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend Henry Bishop of Worcester, as Visitor of the said Chapter, in testimony whereof he hath hereunto set his hand and episcopal seal, that the said sum of four hundred and fifty-eight pounds, standing in the name of the Accountant-General of the Court of Chancery in the Bank of England as aforesaid, and also the said sum of two hundred and seventy pounds, in the hands of the said Edmund Hungerford Lechmere and John Whitmore Isaac, shall be forthwith paid to the said Dean and Chapter of Worcester, and shall be applied by them in the purchase of all the leasehold estate and interest in the dwelling-house and premises described in the said schedule, and that so much of the said sum of one hundred and twenty-two pounds seven shillings and five-pence Three per Cent. Consolidated Bank Annuities, standing in the names of the said Edmund Hungerford Lechmere and John Whitmore Isaac in the Bank of England, as shall be necessary, shall be forthwith sold by them, and the produce paid to the said Dean and Chapter, to be by them applied for the purposes aforesaid; and that thereupon it shall be lawful for the said Dean and Chapter to take down the said dwelling-house and buildings, or any part thereof, and to apply the site thereof, or of any part thereof, to the improvement of the said cathedral church of Worcester and the precincts thereof.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing other measures relating to the matters to which this scheme refers, in conformity with the provisions of the said recited Acts, or either of them.

#### " SCHEDULE.

"A messuage or dwelling-house, called Ivylodge, with the outhouses and buildings, near the west end of the said cathedral church, adjoining or near to the charnel-house, bounded on the north by the Palace-green, on the south by the ground leading to the stables and garden belonging to the fifth canonry or prebendal stall of the said church,

and the garden and garden-ground adjoining the said dwelling-house, as now inclosed with a strong stone wall, and extending from the said house unto the wall of the river Severn, and likewise the court before the said dwelling-house, extending from the same into the cemetry of the said cathedral church."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Worcester.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS by an Act, passed in the session of Parliament held in the third and fourth years of the reign of His late Majesty King William the Fourth, intituled "An Act to "regulate the trade of the British possessions "abroad," it is, amongst other things, enacted, that no goods should be imported into, nor should any goods, except the produce of the fisheries in British ships, be exported from any of the British possessions in America by sea, from or to any place other than the United Kingdom, or some other of such possessions, except into or from the several ports in such possessions called free ports, enumerated in the table therein following :

And whereas it is by the said Act provided, that, if His Majesty shall deem it expedient to extend the provisions of the said Act to any port or ports not enumerated in the said table, it shall be lawful for His Majesty, by Order in Council, to extend the provisions of the said Act to such port or ports; and, from and after the day mentioned in such Order, all the privileges and advantages of the said Act, and all the provisions, penalties, and forfeitures therein contained, shall extend, and be deemed and construed to extend, to any such port or ports, respectively, as fully as if the said table at the time of passing the said Act:

And whereas Her Majesty doth now deem it expedient to extend, in manner hereinaftermentioned, the provisions of the said Act to the port of New Edinburgh, in St. Mary's Bay, in the province of Nova Scotia:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and by virtue and in exercise of the powers in Her in that behalf vested by the said recited Act, doth order, and it is hereby ordered, that, from and after the first day of May next, the port of New Edinburgh, in St. Mary's Bay, shall be a free port; and all the privileges and advantages by the said recited Act conferred upon the free ports thereinmentioned, and all provisions, penalties, and forfeitures therein contained, subject to the limitations and restrictions therein provided, the shall extend, and be deemed and construed to extend, to the said port of New Edinburgh, as fully and effectually as if the same had been inserted and enumerated in the said table of free ports at the time of the passing of the said recited Act:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Lord Stanley, are to give the necessary directions herein accordingly.
