HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with cortain modifications, the fourth report of the

"Commissioners of Ecclesiastical Duties and "Revenues;" and of an Act, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled "An Act " to explain and amend two several Acts relating " to the Ecclesiastical Commissioners for Eng-"land;" and of an Act, passed in the last session of Parliament, intituled "An Act for " regulating the cathedral churches of Wales," duly prepared and laid before Her Majesty in Council a scheme, bearing date the sixth day of August in the year one thousand eight hundred and forty-four, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry into effect, with cer- tain modifications, the fourth report of the "Commissioners of Ecclesiastical Duties and "Revenues;" and of an Act, passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled "An Act to explain and amend two several Acts re-

"lating to the Ecclesiastical Commissioners for England;" and of an Act, passed in the last session of Parliament; intituled "An Act for regulating the cathedral churches of Wales," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for making additional provision for the cure of souls in certain parishes where such assistance is most required.

"Whereas, under the authority of the said recited Acts, we have, from time to time, prepared and laid before your Majesty in Council certain schemes, in which we have recommended and proposed that certain grants should be made, in augmentation of the incomes of certain benefices and churches, in certain classes, and subject to certain limitations therein mentioned; which schemes have been ratified by Orders of your Majesty in Council, and such Orders have been duly gazetted:

"And whereas we have satisfied ourselves, after due inquiry, that the benefices and churches described in the schedules hereunto annexed, marked A. 1, A. 2, A. 3, and A 4, fall within the first of such classes, subject to the respective limitations in the said Orders mentioned; and that all the said benefices and churches are fit and proper to be forthwith augmented by the respective annual amounts stated in the last column of the said schedules respectively:

"And whereas from the source set opposite to the name of each of the benefices and churches described in the schedule hereunto annexed, marked B., in the sixth column of such schedule, the benefaction stated in the seventh column of the same schedule has either been paid to us on account of such benefice or church, or permanently secured to the incumbent thereof, as therein respectively specified; and we have satisfied ourselves that the said last-mentioned benefices and churches fall within the second of such classes, as limited by the said Orders; and are fit and proper to be forthwith augmented, by the respective annual amounts stated in the last column of the same schedule:

"And whereas by reason of the appropriation of certain fees arising within districts recently assigned to certain new churches, the incumbents of the several benefices mentioned in the schedule

hereunto annexed, marked D., will sustain an annual average loss to the amounts respectively set opposite the names of such benefices in the last column of the same schedule, and it is in our opinion expedient, that compensation to the same amount should be made to such incumbents:

"And whereas in the case of Paulton, contained in the said schedule marked B., a benefaction was long since paid over to us, for the joint purpose of providing a house of residence for, and augmenting the income of, the said living, but the precise amount available for such augmentation of income could not be ascertained until the completion of such house; and such house is now completed:

"We, therefore, humbly recommend and propose, that there shall be paid by us, in each and every year, to the incumbent for the time being of each of the benefices and churches so described in the said schedules, marked respectively A. 1, A. 2, A. 3, A. 4, B. and D. the fixed annual sum set opposite to the name of such benefice or church, in the last column of the said schedules respectively, by equal half-yearly payments, on the first day of May and the first day of November in each year; and that the first such half-yearly payment shall, in each case, be made on the first day of November next; except in the case of Paulton aforesaid, the incumbent whereof shall, on such last-mentioned day, receive five such half-yearly payments of the annual sum mentioned in the said schedule B.; and that in case of a vacancy in any of the benefices or churches contained in the said four schedules having already happened during the period over which the payment so recommended and proposed extends, or hereafter happening on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the incumbent making the vacancy, or his personal representatives, and the incumbent succeeding to the benefice or church so becoming vacant.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measure for making better provision for the cure of souls, in conformity with the provisions of the said recited Acts, or either of them."

HEREAS by a certain Act of Parliament, made and passed in the session of Parliament holden in the sixth and seventh years of Her Majesty's reign, intituled "An Act to "enable Her Majesty to provide for the government of Her settlements on the coast of Africa, and in the Falkland Islands," it is, amongst other things, enacted, that it shall be lawful for Her Majesty, by any Order or Orders to be by Her made, with the advice of Her Privy Council, to establish all such laws, institutions, and ordinances, and to constitute such courts and officers, and to make such provisions and regulations for the proceedings in such courts,

and for the administration of justice, as may be necessary for the peace, order, and good government of Her Majesty's subjects, and others, within the said present or future settlements, respectively, or any of them; any law, statute, or usage to the contrary in anywise notwith-

standing:

And whereas by another Act of Parliament, made and passed in the same session of Parliament, intituled "An Act to remove doubts as to the "exercise of power and jurisdiction by Her "Majesty within divers countries and places out "of Her Majesty's dominions, and to render the "same more effectual," it is, amongst other things, enacted, that it is and shall be lawful for Her Majesty to hold, exercise, and enjoy any power or jurisdiction which Her Majesty now hath, or may at any time hereafter have, within any country or place out of Her Majesty's dominions, in the same and as ample a manner as if Her Majesty had acquired such power or jurisdiction by the cession or conquest of territory:

And whereas Her Majesty hath power and jurisdiction within divers countries and places adjacent to Her Majesty's forts and settlements on the gold coast, in Africa, Her Majesty is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, that all judges, magistrates, assessors, and other officers duly appointed to exercise the said power and jurisdiction in the name and on the behalf of Her Majesty, within the countries and places aforesaid, shall, in the exercise thereof, observe, until further order, such of the local customs of the said countries and places as may be compatible with the principles of the law of England, and, in default of such customs, shall proceed in all things, as nearly as may be, according to the said law of England; and, in further pursuance of the powers by the said Acts of Parliament vested in Her Majesty, Her Majesty is pleased, by and with the advice of Her Privy Council, to appoint the settlement of Cape Coast Castle and the colony of Sierra Leone as British colonies, to which it shall be lawful for any person having authority derived from Her Majesty in that behalf, by warrant under his hand and seal, to cause any person charged with the commission of any crime or offence, the cognizance whereof may at any time appertain to any judge, magistrate, or other officer of Her Majesty within the countries and places aforesaid, to be sent for trial, or in order that sentences, passed within such countries and places as aforesaid, may be carried into effect within such colonies:

And the Right Honourable Lord Stanley, one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

- "We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act "to carry into effect, with certain modifications, "the fourth report of the Commissioners of "Ecclesiastical Duties and Revenues;" have prepared, and now humbly lay before your Majesty in Council, the following scheme, for making better provision for the cure of souls in certain parishes.
- "Whereas it is by the said Act enacted, with an especial view to the better care of populous parishes, that arrangements may, from time to time, be made by the authority therein provided for improving the value or making a better provision for the spiritual duties of ill-endowed parishes or districts, by means of such alterations in the exercise of patronage as may be agreed upon by patrons, with the consent of the bishop:
- "And whereas the benefices or churches, mentioned and described in the schedule hereunto annexed, are all situate in populous parishes; but, being respectively in the patronage of the patron or patrons named in the sixth column of the said schedule, they are not within the provisions of the several Orders of your Majesty in Council respecting grants in augmentation of benefices and churches out of the monies in our hands under the said recited Act, so far as such provisions relate to unconditional grants; and, in order to bring them within such provisions, the said patrons desire to transfer their rights of patronage in such benefices and churches respectively, in manner hereinafter mentioned:
- "We, therefore, recommend and propose, with the consent of the bishops of the respective dioceses, and of such present patrons respectively, and also with the consent of the proposed patrons respectively named in the seventh column of the same schedule (in testimony whereof all the said consenting parties have signed and sealed this scheme), that the patronage of and right of nomination to such benefices and churches shall respectively become and be transferred to and absolutely vested in such proposed patrons so named in the said seventh column, and their respective successors for ever.
- "And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measure for making better provision for the cure of souls within the said parishes, or otherwise, in conformity with the provisions of the said recited Act."

Railway Department, Board of Trade, Whitehall, 9th September 1844.

EFERRING to the notice in the Gazette of the 23d August, announcing the intention of the Railway Board to examine into certain schemes therein enumerated, with a view to the presentation to Parliament of minutes or reports therein, in the event of their becoming the subjects of application to Parliament, the Board hereby, give notice, that it is further their intention to examine, with a similar view, into the following schemes, viz.

I. The scheme proposed for extending railway communication through South Wales to Pembroke and Fishguard.

II. The Trent-valley scheme, from Stafford to

III. The Churnet-valley scheme, from Macclesfield to Derby and Tamworth.

IV. The proposed branches of the Grand Junction Railway Company, to connect Shrewsbury, Dudley, and the Potteries with their line, and to shorten the distance to Liverpool by means of a new line across the Mersey, leaving the Grand Junction line near Preston-brook.

V. The Leeds and Thirsk scheme, and, in connection with it, other schemes proposed for connecting Harrogate and Knaresborough with the Great North of England or York and North

Midland Railways.

VI. The Lancashire and Yorkshire Junction scheme, from Blackburn, by Burnley, Skipton, and Keighley, to Leeds and Bradford, and, in connection with it, the Blackburn, Burnley, and Accrington, Leeds and Bradford extension, and other schemes for accommodating portions of the same district.

VII. The Scottish central and other schemes, for extending railway communication north of the Forth to Stirling, Perth, Dundee, and AberVIII. The Lynn and Ely scheme. IX. The Belfast and Ballymena scheme.

X. The Liverpool, Ormskirk, and Preston scheme.

The principal points into which enquiry will be made, in connection with the above schemes, are as follows:

1st. The ability and bona fide intention of the promoters to prosecute their application to Parliament next session for Bills to authorize the several undertakings.

2d. The advantages to be obtained, in a national point of view, in completing or extending important lines of railway communication.
3d. The amount of local advantage afforded to

3d. The amount of local advantage afforded to the towns and districts more immediately affected.

4th. The engineering circumstances of the line, so far as may be necessary to form a general judgment of the character of the undertaking.

5th. The estimates of cost of construction, and of traffic and working expences, so far as may be necessary to judge of the probability of the line being completed and efficiently worked, in the event of its being sanctioned by Parliament, and with a view to drawing a comparison between the merit of competing lines of railway.

The inquiry, in conformity with the recommendation of the fifth report of the Select Committee on Railways, will not embrace questions of private property or interest, which will be reserved altogether for the consideration of the Legislature.
