### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the last session of Parliament, intituled "An Act to make better provision for the "spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the sixth day of August, in the year one thousand eight hundred and fortyfour, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the last session of Parliament, intituled "An Act to "make better provision for the spiritual care of "populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for constituting a separate district for spiritual purposes, out of each of the parishes of Darlaston, in the county of Stafford, Great Dawley, in the county of Salop, and Saint Alkmund, Derby, in the county of Derby, all in the diocese of Lichfield.

"Whereas it is by the said Act enacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent, and containing a large population, and wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is

by the same Act provided, that the draft of any scheme for constituting any such district shall be delivered or transmitted to the incumbent and to the patron or patrons of the church or chapel of any parish, chapelry, or district, out of which it is recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the meantime, consent to the same; and it is by the same Act also provided, that in every such scheme for constituting any such district we shall recommend to your Majesty in Council, that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one hundred and fifty pounds, that the same shall be increased to such last-mentioned amount at the least, so soon as such district shall have become a new parish as thereinafter provided:

"And whereas the said parishes of Darlaston, Great Dawley, and Saint Alkmund, Derby, are, respectively, of great extent, and contain a large population, and the provision for public worship and for pastoral superintendence therein is insufficient for the spiritual wants of the inhabitants thereof; and it has been made to appear to us, that it would promote the interests of religion, that the particular part of each of the said parishes hereinafter described, neither of which parts at present contains within its limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district in manner hereinafter set forth:

"Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend John Bishop of Lichfield, in testimony whereof he has signed and sealed this scheme, that all that part of the said parish of Darlaston, described in the schedule hereunto annexed, and therein num-

bered 1, and also all that part of the said parish of Great Dawley, in the same schedule also described and numbered 2, and also all that part of the said parish of Saint Alkmund, Derby, in the same schedule also described and numbered 3; all which parts, together with the boundaries thereof, respectively, are delineated and set forth in the maps or plans hereunto also annexed, and, respectively, numbered in like manner, shall be constituted separate districts for spiritual purposes accordingly; and that the same shall be respectively named as follows, that is to say, the district numbered 1 in the said schedule shall be named, " The District of Saint George, Darlaston;" the district numbered 2 therein shall be named, " The District of Little Dawley;" and the district numbered 3 therein shall be named, " The District of Saint Paul, Derby."

" And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of each of the districts so recommended to be constituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within any of such districts, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to the minister for the time being of such district, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within any of such districts shall have been duly approved by us, and consecrated as the church or chapel of such district for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sums of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid, by equal half-yearly payments, on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence

of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in case a vacancy in the ministry or perpetual curacy of any of such districts or new parishes shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, in accordance with the provisions of the said Act, or of any other Act of Parliament.

" SCHEDULE. " No 1.-The District of SAINT GEORGE, DAR-LASTON, being

"All that part of the parish of Darlaston, in the county of Stafford, and in the diocese of Lichfield, situate on the northern and eastern sides of an imaginary line extending, first eastward, from the north-western boundary of the said parish of Darlaston, along the middle of a certain public footpath leading from Willenhall to the Longlands, in the same parish, and along the middle of a certain occupation road through the Longlands, as far as the middle of the high road from Darlaston-green to lands at Rough-hay (marked a on the map or plan, No. 1, herewith), and thence eastward, along the middle of such road to a point opposite to the middle of Radley Gutterlane (marked b as aforesaid), and thence southward, along the middle of such last-mentioned lane, as far as the middle of another footpath or lane leading to Blockhall, in the town of Darlaston (marked c as aforesaid), and thence eastward, along such last-mentioned footpath or lane as far as the middle of the street or lane called Cramphill (marked d as aforesaid), and thence southward, along the middle of such street or lane to a point opposite to the north-western corner of a certain chapel called the Independent Chapel (marked e as aforesaid), and thence eastward, in a straight direction, along the northern side of such chapel, and southward, along the eastern side of the same chapel, and thence eastward, across Church-street,

and along the middle of the street or lane called Dale-end, and southward, along the middle of the same street or lane to a point opposite to the middle of Walsall-street (marked f as aforesaid), and thence eastward, along the middle of such last-mentioned street and of a certain public footroad, and of another occupation road, as far as the middle of the road from Darlaston-green to Wednesbury (marked g as aforesaid), and thence towards the south-east, along the middle of such last-mentioned road as far as the Heath (marked has aforesaid), and thence along a fence on the western side of the Heath aforesaid, and on the eastern side of certain land belonging to Messrs. Bills and Mills, as far as the south-eastern boundary of the said parish of Darlaston (marked i as aforesaid).

### "No. 2.-The District of LITTLE DAWLEY, being

"All that part of the parish of Dawley, in the county of Salop, and in the said diocese of Lichfield, comprising the whole township of Little Dawley, and such part of the township of Great Dawley as is situate on the western side of an imaginary line extending from a point in the footroad on the north-eastern side of Horsehaypool, where such footroad crosses the common boundary of the parishes of Dawley and Wellington (marked a on the map or plan, No. 2, herewith), and thence towards the south-east, along the middle of such footroad, as far as the railroad leading to Horsehay Iron Works (marked b as aforesaid), and thence first southward, along the middle of the said railroad, as far as the said iron works (marked c as aforesaid), and thence first eastward, along the middle of another railroad leading from the same works round the Pottery to Pool-hill-lane (marked d as aforesaid), and thence towards the south-east, along the middle of the said lane, to a point opposite to the eastern boundary fence of Pool-hill-meadow, and of gardens at the north-eastern and south-eastern corners, respectively, of the same meadow (marked e as aforesaid), and thence first southward; along such last-mentioned boundary fences to the south-western corner of the said fence (marked f as aforesaid), and thence continuing in a direct line with such fence, as far as the boundary of the township of Little Dawley (marked g as aforesaid).

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the said parish, or to the said districts or new parishes, or either of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.
