ship of Ryhope, in the parish of Bishop Wearmouth, in the said county of Durham, and passing thence from, in, through, or into the several parishes, townships, extra-parochial, or other places of Bishop Wearmouth, Seaham, Dalton-le-Dale, Ryhope, Seaton otherwise Seaton cum Slingley, Seaham and Dalden otherwise Dawdon otherwise Dalton-le-Dale, or some of them, all in the said county, and to terminate at or near to the toll-bar or check-gate adjoining or near to the entrance into the town of Seaham Harbour, at the Dalden Dene, in the township of Dalden otherwise Dawdon otherwise Dalton-le-Dale, in the parish of Dalton-le-Dale, in the said county; and to make and maintain another branch railway from and out of the said main line of the said Durham and Sunderland Railway, with all proper works and conveniences connected therewith, and approaches thereto, to commence at or near to the Seaton Bank Station in the said township of Seaton otherwise Seaton cum Slingley, in the parish of Seaham aforesaid, in the said county of Durham, and passing thence from, in, through, or into the several parishes, townships, extra-parochial, or other places of Seaham, Dalton-le-Dale, Seaton otherwise of Seaham, Dalton-le-Dale, Seaton otherwise Seaton cum Slingley, Seaham and Dalden otherwise Dawdon otherwise Dalton-le-Dale, or some of them, all in the said county, and to terminate at, in, near, or adjoining to a certain street or place, at, in, or near to the said town of Seaham Harbour, and called or known by the name of Railway Street, in the said township of Dalden otherwise Dawdon otherwise Dalton-le-Dale, in the parish of Dalton-le-Dale aforesaid, in the said county; and to make and maintain another branch railway from and out of the said main line of the said Durham and Sunderland Railway, with all proper works and conveniences connected therewith, and approaches thereto, to commence at or near to a certain place called or known by the name of Hendon, otherwise Hendon Terrace, adjoining or near to Sunderland Moor, in the township of Bishop Wearmouth, in the said parish of Bishop Wearmouth, in the said county of Durham, and passing thence from, in, through, or into the several parishes, townships, extra-parochial, or other places of Bishop Wearmouth, Sunderland near the Sea, Hendon, and Sunderland Moor, or some of them, all in the said county, and to terminate at a certain point on Sunderland Moor, in the said township of Sunderland near the Sea, in the parish of Sunderland near the Sea, aforesaid, and adjoining or near to a certain street or place, called or known by the name of Cousin Street, in the said township of Bishop Wearmouth, in the parish of Bishop Wearmouth aforesaid, in the said county; and to make and maintain another branch railway from and out of the Haswell branch of the said Durham and Sunderland Railway, with all proper works and conveniences connected therewith, and approaches thereto, to commence at a certain point in the said Haswell Branch Railway, in a certain field or parcel of ground belonging to Sir George Shee, Baronet, and in the occupation of Thomas Richardson, situate in the township of Belmont Branch Railway," as the same have been Haswell, in the parish of Easington, in the said already constructed and made, commencing at a
