And it is intended by the said Act so to be applied for, to take powers to enable the said Durham and Sunderland Railway Company to abandon and relinquish, and in lieu thereof to enable the said Durham and Sunderland Railway Company; or other the Company to be thereby incorporated, to construct other works upon, and to make deviations from and alterations or diversions in certain portions of the main line of the said Durham and Sunderland Railway, commencing at, near to, or adjoining the station or station-house and premises of and belonging to the said Durham and Sunderland Railway Company situate in and upon a certain tract or parcel of unenclosed land known by the name of Sunderland Moor, belonging to the ancient corporation of the freemen and stallingers of Sunderland, and in the occupation of the said Durham and Sunderland Railway Company, situate in the township of Sunderland near the Sea, in the parish of Sunderland near the Sea, in the said county Durham, and passing thence from, in, through, or into the several parishes, townships, extra-parochial or other places of Sunderland near the Sea, Bishop Wearmouth, Seaham, Dalton-le-Dale, Houghton-le-Spring, Pittington, Saint Oswald, Ryhope, Seaton otherwise Seaton-cum-Slingley, Dalden otherwise Dawden otherwise Dalton-le-Dale, Murton otherwise Murton-in-the-Whins otherwise East Murton, Great Eppleton, Little Eppleton, Hetton-le-Hole, Moorsley, East Rainton, West Rainton, Moor House, Pittington otherwise Pittington Hallgarth, Broomside, Sherburn, Sherburn House, Shincliffe, and Elvet Barony, or some of them, all in the said county, and terminating at or in a certain close or field adjoining or near to the river Wear, and situate in the said township of Elvet Barony, in the parish of Saint Oswald aforesaid, in the said county, and in the occupation of the said George Bell, or any part or parts thereof, and the powers, authorities, and rights of the said Durham and Sunderland Railway

And it is intended by the Act so to be applied for, to take powers to enable the said Durham and Sunderland Railway Company, or other the Company to be thereby incorporated, to purchase all and singular the lands or grounds, messuages, tenements, hereditaments and premises and other property in, through over or upon which the said portions of the said main line of railway have been respectively already constructed and made, and are now maintained, used, and enjoyed by the said Durham and Sunderland Railway Company, and in, through, over, or upon which the said deviations and alterations, or diversions, and other works and conveniences, are severally and respectively intended to be made and constructed, and also to purchase and take all and singular the lands or grounds, messuages, tenements, hereditaments, and premises and other property in, through, over, or upon which the said Haswell Branch Railway of and belonging to the said Durham and Sunderland Railway Company has been constructed and made, and is now maintained, used, and enjoyed, commencing from and out of the said main line of railway from, at, or near to the Murton Junction station of and belonging to the said Durham and Sunderland Railway Company, situate in the said township of Murton otherwise Murton in the Whins otherwise East Murton, in the said parish of Dalton-le-Dale, in the said county of Durham, and passing thence from, in, through, or into the several parishes, townships, extra-parochial, and other places of Dalton-le-Dale, Easington, Murton otherwise Murton in the Whins otherwise East Murton, and Haswell, or some of them, all in the said county, and terminating at, near to, or adjoining to the said Hartlepool Railway, in the said township of Haswell, in the said parish of Easington; and also to purchase and take all and singular the lands or grounds, messuages, tenements, hereditaments, and premises and other property, in, through, over, or upon which a certain portion of a certain other branch railway of and belonging to the said Durham and Sunderland Railway Company, and called or known by the name of "the Whitwell and Quarrington Branch Railway," has been constructed and made, and is now maintained, used, and enjoyed, commencing from and out of the said main line of railway at, near, or adjoining to the Sherburn station, situate in the township of Sherburn aforesaid, in the said parish of Pittington, in the said county, and passing thence from, in, through, or into the several parishes, townships, extra-parochial, or other places of Pittington, Saint Oswald, Sherburn, Shincliffe, and Whitwell otherwise Whitwell House, or some of them, all in the said county, and terminating at, near, or adjoining to the Whitwell colliery, in the extra-parochial place of Whitwell otherwise Whitwell House aforesaid; and also to purchase and take all and singular the lands or grounds, messuages, tenements, hereditaments, and other property, in, through, over, or upon which a certain portion of a certain other branch railway of and belong-
