Faversham, Store near Faversham, Luddenham, Davington, Ospringe, Faversham, Preston next Faversham, Boughton under the Blean, Selling, Ville of Dunkirk, the hundred of Westgate, Charthem, Saint Michael Harbledown, Saint Nicholas Harbledown, Harbledown, Saint Dunstan, Thannington, and Holy Cross Westgate without the city of Canterbury, in the county of Kent; and Thannington, Chartham, Saint Michael Harbledown, Saint Nicholas Harbledown, Harble-down, Holy Cross Westgate without the city of Canterbury, Saint Dunstan, Nackington, Beakesbourne, Patricksbourne, Bridge, Bishopsbourne, Bourne-place, Charlton, and Kingstone, in the liberty of the city and borough of Canter-bury, and county of the same; Holy Cross Westgate within the city of Canterbury, Saint Peter, Saint Mildred, the precincts of the Old Castle, Saint Mary Bredin, and Saint Paul, in the city of Canterbury and county of the same city; the liberty of Canterbury, the borough of Canterbury, Nackington, Beakesbourne, Patricksbourne, Bridge, Bishopsbourne, Bourne-place, Charlton near Canterbury, Kingston, Deringstone, Gravel-castle, Womenswould, Denhill, Barham, Barham-downs, Gittinge, Denton near Wootton, Broome, Wootton, Sybertswould otherwise Shepherds Well, Lydden, Coldred, Watersend, Ewell otherwise Temple Ewell, Kearsney, River, Crabble, Buckland in and near Dover, Charlton in Dover, Saint James the Apostle Dover, Saint Mary the Virgin in Dover, and Dover, in the said county of Kent. And for making and maintaining two several extensions of or branches from the said intended railway from London to Dover, or one of them, namely; one extension or branch into the city of London, to commence from and out of the said intended railway, at the said two points or places of commencement of the said intended railway, in the parish of Saint Saviour Southwark, between Union-street aforesaid and Peter-street aforesaid, or one of them, and to proceed across the river Thames by means of the Southwark-bridge and its approaches to or near to Bucklersbury, in the parishes of Saint Stephen Walbrook, Saint Benet Sherehog, and Saint Mary Colechurch, and Saint Mary Colechurch Hawe, in the city of London, some or one of them, and which said extension or branch into the city of London is to be made in or to pass from, through, or into the several parishes, liberties, hamlets, extra-parochial and other places following, or some of them, that is to say; Saint Saviour Southwark aforesaid, the liberty of the Clink aforesaid, in the county of Surrey; Saint James Garlick Hythe, Saint Martins Vintry, Saint Michaels Paternoster Royal, Allhallows the Great, Saint Thomas the Apostle, Saint Antholin Watling-street, Saint John the Baptist, Saint Benet Sherehog, Saint Stephen Walbrook, Saint Mildreds Poultry, and Saint Mary Colechurch, and Saint Mary Colechurch Hawe, in the said

city of London; and the other extension or branch towards the west end of London, to commence from and out of the said intended railway, at the said points or places of commencement of the said intended railway in the parish of Saint Saviour branch railway, to commence from and out of th

Southwark aforesaid, between Union-street aforesaid and Peter-street aforesaid, or one of them, and to terminate at the three following points or places, some or one of them, viz.; by a junction with the Lambeth extension of the London and South Western Railway, at or near to the Belvidere Brewery, and adjacent to the intended station of the said Lambeth extension, in the parish of Saint Mary Lambeth aforesaid, and also at or near to the south-end of Waterloo-bridge in the same parish, and also at or near to the south-end of the Charing Cross-bridge otherwise the Hungerford and Lambeth Suspension Bridge, in the parish of Saint Mary Lambeth aforesaid, and which said last-mentioned extension, or branch to the west end of London as aforesaid, is to be made in or to pass from, through, or into the several parishes, townships, hamlets, liberties, and extraparochial and other places following, or some of them, that is to say, Saint Saviour Southwark, the liberty of the Clink, Christchurch, Saint George the Martyr Southwark, and Saint Mary Lambeth, in the county of Surrey.
