

at or near Ulpha Crag, in the parish of Beetham aforesaid; and it is intended to divert through the said cut and canal the water of the river Winster, and all other streams, rivers, and waters which may be intercepted, by the said cut, into the river Kent, and thence, by the other cuts and canals hereinafter mentioned, into the sea; also another cut, canal, or navigation to commence from the south side of the river Kent, opposite Ulpha Crag aforesaid, and the outlet of the last-mentioned cut, and to open into the river Keer, at or near a farm house called Cote Stones, at the present mouth of the said river, and to divert into the said cut the river Kent, and also Leighton Beck, and all other streams which may be intercepted by the said cut; also another cut, canal, or navigation to commence on the southern side of the said river Keer, opposite to the outlet of the said last-mentioned cut, and to open into and upon the said Lancaster Sands, at or near a place called Hest Bank, which said two last-mentioned cuts will be made in and pass through the several parishes, townships, and extra-parochial places following, that is to say; Beetham, Meathop and Ulpha, Witherslack, Haverbrack, Arnside, Heversham, Milnthorpe with Heversham, Warton, Silverdale, Yealand Redmayne, Yealand Conyers, Warton with Lindelth, Carnforth, Bolton-le-Sands, Nether Kellet, Over Kellet, Slyne otherwise Slyne with Hest, Hest Bank, and the Sea Shore and Sands, called Lancaster Sands, and Morecambe Bay, or some of them, all in the county palatine of Lancaster, or the county of Westmoreland.

And notice is hereby further given, that a plan of the said railways and works, and also a duplicate of such plan, and a section and duplicate thereof, together with books of reference thereto, will be deposited, for public inspection, with the Clerk of the Peace for the said county palatine of Lancaster, at his office at Preston, in the said county; and with the Clerk of the Peace for the said county of Westmoreland, at his office at Appleby, in the said county, on or before the thirtieth day of November one thousand eight hundred and forty-five; and, on or before the thirty-first day of December following, a copy of so much of the said plans and sections as relates to each parish in or through which the said works are intended to be made, together with a book of reference thereto, will be deposited with the parish clerk of each such parish, at his place of abode.

And notice is hereby further given, that it is intended, in the said Bill or Bills, to apply for powers for the compulsory purchase of lands and houses, and all rights and interests therein, and to vary or extinguish all rights and privileges in any manner connected with the lands and houses proposed to be taken for the purposes aforesaid; and also to levy tolls, rates, or duties upon or in respect of the said railways and works, and to alter existing tolls, rates, or duties, and to confer, vary, or extinguish exemptions from the payment of tolls, rates, and duties, and other rights and privileges.—Dated this eighth day of November 1845.

NOTICE is hereby given, that application is intended to be made to Parliament in the next session, for leave to bring in a Bill to exempt the occupiers of houses, cottages, or tenements within the several parishes, hamlets, liberties, and places within the city of Norwich, and county of the same city, not exceeding the clear annual rent or value of six pounds, from the payment of poors' rates, or to authorize the rating and assessing to the relief of the poor, the landlords, owners, or proprietors of such houses, cottages, or tenements in lieu of the several occupiers thereof; and for repealing or for altering, amending, and rendering more effectual some of the powers or provisions of an Act, passed in the session of Parliament held in the first and second years of the reign of His late Majesty King William the Fourth, intituled "An Act for the better management of the poor in the several parishes and hamlets in the city of Norwich and county of the same city," relating to the said rates for the relief of the poor, and to the assessment, collection, and recovery thereof, or of any compositions for the same; and which said city, and county of the same city, comprise the several parishes, hamlets, liberties, and places following, that is to say; Saint Peter of Mancroft, Saint Peter per Mountergate, Saint Stephen, the liberty called the Town Close, Saint Giles, Saint Andrew, Saint George of Tomland, Saint George of Colegate, Saint Peter of Southgate, Saint Etheldred, Saint Julian, Saint John of Sepulchre, Saint Michael at Thorn, Saint John of Timberhill, All Saints, Saint Benedict, Saint Swithin, Saint Margaret, Saint Lawrence, Saint Gregory, Saint John of Maddermarket, Saint Michael at Plea, Saint Peter of Hungate, Saint Simon and Jude, Saint Martin at Palace, Saint Helen, the hamlet of Thorpe, Saint Michael of Coslany, Saint Mary of Coslany, Saint Martin at Oak, Saint Augustine, Saint Clement, Saint Edmund, Saint Saviour, Saint Paul, Saint James, and the hamlets of Pockthorpe, Eaton, Earham, Hellesdon, Lakenham, Heigham, Trowse, Millgate, Carrow, and Bracondale; and also for exempting from the payment of church, borough, watch, highway, and other parochial and local rates, such occupiers as shall be exempted from the payment of poors' rates by the proposed Bill, or to empower the several persons authorized by law to make and assess church, borough, watch, highway, and other parochial and local rates, to assess to such rates the landlords, owners, or proprietors of houses, cottages, or tenements within the several parishes, hamlets, liberties, and places within the said city and county of the same city, not exceeding the clear annual rent or value of six pounds; and in which Bill provisions are intended to be inserted for levying rates for altering the making and assessing the same, and for compounding for rates, and for conferring, varying, or extinguishing exemptions from the payment of rates, and other rights and privileges.
