And also power to make and maintain a main line railway, with all proper works, stations, and other conveniences connected therewith, diverging from the before-described trunk railway, at or near Aldam Mill, in the said township of Wombwell, in the parish of Darfield, in the said west riding of the county of York, passing thence from, in, through, or into the several parishes, townships, extra-parochial, and other places of Darfield parish, Darfield township, Wombwell, Worsbrough, Ardsley, Roystone parish, Roystone township, Cudworth, Monk Bretton otherwise Burton, West Bretton, Woolley, Dodworth, Carlton, Notton, Silkstone parish, Silkstone township, Barnsley, Cawthorne parish, Cawthorne township, upper division of Cumberworth, Darton parish, Darton township, Barugh, Thurlstone, Kexborough, Skelmanthorpe, Gawber, Ingbirchworth, Penistone parish, Penistone township, Denby, Denby Dale, Upper Denby, Nether Denby, Hoyland, High Hoyland parish, High Hoyland township, West Clayton, Roydhouse, Thunderbridge, Woodhouse, lower division of Cumberworth, Emley parish, Emley township, lower division of Cumberworth Half, Cumberworth Half, Cumberworth, Cumberworth-with-Skelmanthorpe, Kirkburton parish, Kirkburton township, Shelley, Siset, Thurstonland, Shepley, Highburton, upper division of Cumberworth Half, all, or some, or one of them; and terminating by a junction with the Huddersfield and Sheffield Junction Railway, near Abbey Lane, in the township of Shepley, in the parish of Kirkburton.

And also power to make and maintain the following branch railways and tramroads, with all

proper works, stations, and conveniences connected therewith, namely:—

A branch railway or tramroad diverging from the said main trunk railway, in the said township of Wombwell, and passing in and through the said township of Wombwell, through, into, and terminating in the said township of Worsbrough, both in the said parish of Darfield.

A branch railway or tramroad diverging from the said main trunk railway, in the said township of Denaby otherwise Dannaby, in the said parish of Mexbrough, passing thence from, in, through, or into the several parishes, townships, extra-parochial and other places of Denaby otherwise Dannaby, Mexbrough parish, Mexbrough township, Wath-upon-Dearne parish, Wath-upon-Dearne township, Hooton Roberts parish, Hooton Roberts township, Thribergh parish, Thribergh township, Rawmarsh parish, Rawmarsh township, Swinton and Kilnhurst, or some of them; and terminating by a junction with the Midland Railway, at or near Kilnhurst, in the parish of Wath-upon-Dearne or Rawmarsh.

A branch railway or tramroad diverging from the said main trunk railway at, in, or near the said township of Adwick-on-Dearne, in the said parish of Wath-upon-Dearne, and terminating therein by a junction with the said Midland Railway.

A branch railway or tramroad diverging from the said main trunk railway, in the said township of Brampton Bierlow, in the said parish of Wath-upon-Dearne, passing thence from, in, through, or into the several parishes, townships, extra-parochial and other places, of Brampton Bierlow, Wath-upon-Dearne township, Wath-upon-Dearne parish, Wombwell, Darfield parish, Darfield township, Wentworth, Hoyland, or some of them, all in the said west riding of the county of York; and terminating by a junction with a certain railway or tramway, the property of Earl Fitzwilliam, in the said township of Hoyland, in the parish of Wath-upon-Dearne.

A branch railway or tramroad diverging from the said main trunk railway, in the said township and parish of Conisbrough, and passing thence from, in, through, or into the several parishes, townships, extra-parochial and other places of Conisbrough parish, Conisbrough township, Warmsworth parish, Warmsworth township, Butterbusk, Levett Hagg, Cusworth, Sprotbrough parish, Sprotbrough township, or some of them; and terminating in or near Levett Hagg, in the said township and parish of Warmsworth.

A branch railway diverging from the said main trunk railway, in the said township of Warmsworth, in the said parish of Warmsworth, passing thence from, in, through, or into the following parishes, townships, extra-parochial and other places of Warmsworth parish, Warmsworth township, Balby with Hexthorpe, Hexthorpe, Alverley, Wadworth, Doncaster parish, Doncaster township, Loversall, Edlington, Stancill with Wellingly and Wilsick, Tickhill, Cantley township, Cantley parish, Rossington parish, Rossington township; or some of them; and terminating by a junction with the said intended railway to be called "The Great
