And also for making and maintaining a reservoir or reservoirs, near to the said intended port or harbour, with all necessary embankments, aqueducts, channels, works, and conveniences connected therewith, for the purpose of diverting, collecting, conveying, impounding, and penning up the water usually flowing down or through certain brooks, streams, watercourses, or rivulets, called, respectively, Cannington Brook, Blindman's Marsh Brook, New Brook, Old Brook, Little Arch Brook, Great Arch Brook, and Cold Lane Brook, some or one of them; which said brooks, streams, watercourses, or rivulets, or some or one of them, or some part or parts thereof respectively, pass and flow in and through the several parishes, townships, and extra-parochial and other places of North Petherton Hundred, Chilton-Trinity, Hunstill, Wembdon, Cannington Hundred, Cannington, Edstock, Beer, Gurney Street, Perry Green, Cannington Clyse, Whitley Hundred, Blindman's or High Style Clyse, Stockland-Bristol, Otterhampton, New Clyse, Williton and Freemanners Hundred, Lilstock otherwise Little-Stoke, Stogursey otherwise Stoke-Courcy, Burton, Knighton, Shurton, Old Clyse, Wick Park or Week Park, Zine, Itson, Chalcott, Whitewick, Gorpit, Stoford or Stolford, Week or Wick, and Headware, some or one of them, into the river Parret and Bristol Channel, in the Bay of Bridgewater, or one of them, all in the county of Somerset. And for supplying, from such reservoir or reservoirs and works, water for the use and convenience of the said port or harbour, piers, docks, basins, and works; and also to authorize the diversion or alteration of the courses of the said several brooks, streams, watercourses, or rivulets, some or one of them; and also to lay down moorings, buoys, and other conveniences for navigation, in the said river Parret and Bristol Channel, in the neighbourhood of the said intended port or harbour; which said port or harbour, piers, docks, basins, landing-places, cut, channels, reservoir or reservoirs, works, and conveniences hereinbefore mentioned, are intended to be made and maintained within, and to pass from, in, through, or into, or to be situate in, the several parishes, townships, and extra-parochial and other places of Williton and Freemanners Hundred, Lilstock otherwise Little-Stoke, Cannington Hundred, Stogursey otherwise Stoke Courcy, Burton, Knighton, Shurton, Stoford or Stolford, Week or Wick, Moun-ton District, Borough District, Durborow District, Shurton District, Benhole, Bullen, Hannams, Headware, Zine, Itson, Gorpit, Whitewick, Chalcott, Woolstone, Stockland-Bristol, Otterhampton, Hill, Combwich, Hunts-pill, Cannington, Edstock, Beer, Gurney Street, Shepherds, Trepit, Perry Green, Perry Court, Wallen, Pawlett, Andersfield Hundred, Chilton Trinity, Whit-lëy Hundred, Hunstill, Sandford, Clay Hill, Coke-hurst, Allins, North Petherton Hundred, and Wemb-don, or some of them, in the county of Somerset.

And it is also intended in and by such intended Bill or Bills, to obtain powers to enable the company or companies to be thereby incorporated to purchase and take or rent, and to enable the Company of Proprietors

of the Bridgewater and Taunton Canal Navigation to sell and absolutely dispose of, or to lease, the canal, basin, docks, lands, and works, known as the Bridge-water and Taunton Canal Navigation, and also the River Tone Navigation, belonging to the said canal company, and all the lands, hereditaments, estates, rights, titles, interest, property, and effects in the said Canal Navigation and River Tone Navigation respec-tively, or connected therewith respectively, and all rights, powers, and privileges in relation thereto respectively; and also to enable such intended company or companies, or the said Company of Proprietors of the Bridgewater and Taunton Canal Navigation, to stop up all or any portion or portions of the said Bridgewater and Taunton Canal Navigation, basin, docks, and works, respectively, and to use all or any portions thereof respectively, for the purposes of the said railways, or either of them, and also to maintain, manage, and work the said Bridgewater and Taunton Canal Navigation, basin, docks, and works, respec-tively, and the said River Tone Navigation and works, or any portion or portions of the said canal and river navigations, or either of them, and to levy and raise the tolls, rates, and duties which are authorized to be levied and raised for and in respect of the use of the said Bridgewater and Taunton Canal Navigation, basin, docks, and works, and the said River Tone Navigation, respectively, which said Bridgewater and Taunton Canal Navigation, and the works, lands, and heredita-ments belonging thereto, is and are situate in the sever-ral parishes, townships, and extra-parochial and other places following, or some of them, that is to say, North Petherton Hundred, Wembdon, West Street, Bridge-water, Borough of Bridgewater, Hamp, North Pether-ton, Huntworth, Petherton, Ford Gate, Moorland, Standards, Pye Corner, Newton, North Newton, Saint Michael-Church, Mansell, Bankland, Stastings, Out-wood, Outwood Green, Lyng, East Lyng, West Lyng, Durston, Buckland, Old Bucklands, Challerton, Charl-ton, Wood Cross, Court Barton, Andersfield Hundred, Creech Saint Michael, West Monkton, Hyde Farm, Bath Pool End, Bathpool, Maiden Brook, Cheddon-Fitzpaine, Trow Bridge, Taunton and Taunton-Dean Hundred, Taunton Saint James, Plaistreet, Obridge, Firepool, Taunton, and Taunton Borough, or some of them, in the county of Somerset.

And the said river Tone navigation, and the works, lands, and hereditaments belonging thereto, is and are situate in the several parishes, townships, and extra-parochial and other places following, that is to say:
