A branch line of railway, diverging from and out of the said main line of railway, at, in, or near the town or village of Elland, in the township of Elland-cum-Greetland, in the parish of Halifax, in the same West Riding, and to terminate at or near a certain place .called Burr Wood, in the township of Stainland with 'Old Lindley, or in the township of Stainland, or Old Lindley, or one of them, in the said parish of Halifax, and same West Riding, and with the works and conveniences connected therewith, to be made and maintained from, in, through, or into the several parishes, townships, and extra-parochial and other places following, or some of them, that is to say, the said parish of Halifax, and the townships and extra-parochial or other places of Eiland-cum-Greetland, Elland, Greetland, Barkisland, Stainland with Old Lindley, Stainland and Old Lindley, all in the same West Riding.

Another branch line of railway, diverging from and out of the said main line of railway, at, in, or near the town or village of Elland, in the township of Ellandcum-Greetland, or in the township of Elland, in the said parish of Halifax, in the same West Riding, and to terminate by a junction with a certain railway from Manchester to Leeds, called "The Manchester and Leeds Railway," at or near a certain place in the township of Elland-cum-Greetland, or in the township of Elland, or the township of Greetland, or one of them, in the said parish of Halifax, and same West Riding, called North Dean, or North Dean Wood, at or near a certain station constructed, or now in progress of construction there, by the Manchester and Leeds Railway Company, and with the works and conveniences connected therewith, to be made and maintained from, in, through, or into the several parishes, townships, and extra-parochial and other places following, or some of them, that is to say, the said

parish of Halifax, and the townships and extra-parochial or other places of Elland-cum-Greetland, Elland and Greetland, all in the same West Riding.

And notice is further given, that it is intended to apply for powers to be granted by the said Act or Acts, to authorize the deviating from the line of the said intended railway and branch railways, and works and conveniences, to such an extent as will be defined on the plans thereof to be deposited as after mentioned.
