and places for laying pipes for supplying water within the districts aforesaid; and it is intended to take water from the river Chew, and certain springs, streams, brooks, and rivers, situate within the several parishes, townships, and extra-parochial places hereinafter mentioned, or at some place or places at which the same river Chew, and the said other streams, brooks, or rivers run, through such parishes, townships, and extra-parochial places, that is to say, Chewton Mendip, Litton, Emborrow, East Harptree, West Harptree, Winford, Dundry, Barrow otherwise Barrow Gurney, or some them, in the county of Somerset; the waters of which said river Chew, or of the said other springs, streams, brooks, or rivers, partly flow into the river Avon, and into the Kennet and Avon Canal navigation, or one of them, and partly into the Bristol Channel; and it is intended to construct reservoirs both for collecting, pounding, and supplying such water, and for compensating the owners and occupiers of mills and lands affected by the diversion thereof, and for other purposes; which said reservoirs will be situate in the several parishes of Litton, East Harptree, Emborrow, Hinton Blewett, Chew Magna, Winford, Barrow otherwise Barrow Gurney, Dundry, and Bedminster, or some of them, in the county of Somerset; and Westbury upon Trym, in the county of Gloucester, which said river Chew, or of the said other springs, and Westbury upon Trym, in the county of Gloucester, and city and county of Bristol, or one of them; and Clif-ton, in the city and county of Bristol; and to construct aqueducts for conveying and supplying such water, and reservoirs, and water-works, and works connected therewith, which said aqueducts, reservoirs, waterworks, and works will be situate in, or pass from, in, through, or into the several parishes, townships, and extra-parochial or other places following, that is to say, Chewton Mendip, North Widcombe, South Widcombe, Green Ore, Emborrow, Whitnell, Slade Mills, Harbour, Green Ore, Emborrow, Whitnell, Slade Mills, Harbour, Stone Easton, Litton, Sherborne, Hinton Blewett, East Harptree, Shrole, Colley otherwise Coley, otherwise Coaley, Sherbourne, Eastwood, Pitt, Castle of Comfort, West Harptree, Rudge. And in the said Bill or Bills powers will be applied for to enable the company or companies so to be incorperated thereby, to purchase, by compulsion or others wise, any springs, streams, waters, water-courses, reservoirs, houses, lands, tenements, and hereditaments necessary for the purposes aforesaid, and which will be described upon the plans hereinafter mentioned, and to vary and extinguish all rights or privileges in any manner connected with such springs, streams, waters, water-courses, reservoirs, houses, lands, tenements, and hereditaments which would in any manner impede or interfere with the construction or mainte-nance of the said intended works, or any of them; and also to purchase any existing water-works or water-pipes from the owners or lessees thereof, or any of the rights and interests, or reversion of rights or interests of such owners or lessees, and also to confer other rights and privileges; and to enable the said company to carry the said aqueduct or aqueducts and works, or some part thereof, over, under, along, and across any turnpike road, public road, caual, railway, navigation, bridge, dock, or cut, in any of the parishes, townships, and extra-parochial places aforesaid.

And in the said Bill or Bills powers will be applied

for to enable the said company or companies to be incorporated thereby, to levy and recover rates, rents, and duties for the use of the water to be supplied by the said company or companies, and to grant ex-emptions from the payment thereof.

And notice is hereby further given, that duplicate plans, describing the line or course of the said intended aqueduct or aqueducts, and also the situation or situations of the said reservoirs and other works, and of the lands proposed to be taken for the purposes thereof, and describing the springs, brooks, streams, and rivers to be directly diverted, taken, or used for supplying the same reservoirs and aqueducts with water, together with duplicate sections of the said aqueduct or aqueducts, reservoirs, and other works, with books of reference to such plans, containing the names of the owners or reputed owners, lessees or reputed lessees, and occupiers of such lands, will, on or before the thirtieth day of November instant, be deposited for public inspection, at the respective offices of the several clerks of the peace following, offices of the several clerks of the peace following, that is to say, with the clerk of the peace for the city and county of Bristol, at his office at Bristol; with the clerk of the peace for the county of Gloucester, at his office at Gloucester; and with the clerk of the peace for the county of Somerset, at his office at Taunton; and that on or before the thirty-first day of December next a copy of so much of the said plans, sections, and books of reference, as relates to each of the parishes hereinbefore mentioned, from, in, or through which the said aqueduct or aqueducts, reservoirs, and other works, will pass, be or be situate, will be deposited with the parish clerk of each such parish, at his place of abode.
