HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An" Act to amend and render more effectual an Act, "passed in the last session of Parliament, for building, and promoting the building, of addi-"tional churches in populous parishes," duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-second day of October one thousand eight hundred and forty-five, in the words following, viz.

" Your Majesty's Commissioners for building new churches, appointed by virtue of an Act, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled "An " Act for building, and promoting the building, of " additional churches in populous parishes;" continued by an Act, passed in the session of Parliament holden in the seventh and eighth years of the reign of His Majesty King George the Fourth, intituled "An Act to amend the Acts for building, " and promoting the building, of additional churches " in populous parishes;" and further continued by an Act, passed in the first year of your Majesty's reign, intituled "An Act to prolong, for ten years, " Her Majesty's Commission for building new " churches," beg leave humbly to represent to your Majesty, that, having taken into consideration all the circumstances attending the parish of Putney,

in the county of Surrey, and deanery of Croydon, the peculiar and immediate jurisdiction of the cathedral and metropolitical Church of Christ, Canterbury, and now locally situate within the diocese of Winchester, it appears to them to be expedient, that a particular district should be assigned to the consecrated church or chapel of the Holy and Undivided Trinity, situate at Roehampton, the said parish, under the provisions of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His said Majesty King George the Third, intituled "An " Act to amend and render more effectual an " Act, passed in the last session of Parliament, " for building, and promoting the building, of " additional churches in populous parishes;" and that such district should be named, "The Chapelry District of Roehampton," with boundaries as follow:

"The district is to consist of the hamlet of Roehampton, and is bounded on or towards the south by the parish of Wimbledon, on or towards the west by the parishes of Kingston-upon-Thames and Mortlake, on or towards the north by the parish of Barnes, and on or towards the east by the remaining part of the parish of Putney, from which it is divided by proceeding in a southerly direction from a point in the upper road leading from Putney to Richmond, opposite the fence which divides Putney-park from the premises occupied by J. Ridgway, Esq. along the Putney-park fence till such fence turns towards the east; it then continues along that fence easterly, till it reaches Putney-park-lane, and, crossing that lane, proceeds along the northern fence of the premises occupied by Sir Harry Webster, to the north eastern corner thereof; it then turns southerly, down the eastern fence of Sir Harry Webster's premises, until it reaches the northern fence of the premises of Sir George Larpent, which it intersects and runs across a field belonging to the said premises to the eastern fence of the same, which separates the premises of Sir George Larpent from the premises of Thomas Cockburn, Esq. and continues along such fence as far as the High-road from Putney to Roehampton, and crossing the said road follows the boundary of the hamlet of Roehampton, across the common, till it enters the road leading to Kingston from Putney, at the point where the said road crosses a brook running from
