Patney-heath to Rochampton; it then proceeds in a south westerly direction, along that road, as far as the cross road leading into the road from Kingston to Wandsworth, crossing the same proceeds over the common to the boundary of the parish, at an angle thereof, near to the Windmill on Wimbledon-common, as the same is more particularly delineated on the map or plan hereunto annexed, and thereon coloured green :

"That baptisms and churchings should be solemnized and performed in the said church; and that the fees arising therefrom should continue to belong to the Incumbent of the said parish of Putney for the time being :

"That the consents of the Right Honourable and Most Reverend William Lord Archbishop of Canterbury, to whose peculiar jurisdiction the said parish of Putney is now subject, and of the Right Reverend Charles Richard Lord Bishop of Winchester, within whose diocese the said parish of Putney is now locally situate, have been obtained thereto, as required by the above-mentioned section of the said Act, passed in the fifty-ninth year of the reign of His said Majesty King George the Third; in testimony whereof, the said William Lord Archbishop of Canterbury and the said Charles Richard Lord Bishop of Winchester have signed and sealed this present instrument :

"Your Majesty's Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made, and the recommendations of the said Commissioners, in respect of baptisms and churchings, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Act.

I do hereby give notice, that it hath been certified to me in writing, under the hands of two Members serving in this present Parliament, that John Henry Loftus, commonly called Lord Viscount Loftus, late a Member serving in this present Parliament for the borough of Woodstock, is become a Peer of the United Kingdom of Great Britain and Ireland, and to whom a writ of summons hath been issued under the Great Seal of the United Kingdom to summon him to Parliament, and that I shall issue my warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said borough, in the room of the said John Henry Loftus, commonly called Lord Viscount Loftus, now a Peer of the United Kingdom of Great Britain and Ireland, and to whom a writ of summons hath been issued as aforesaid, at the end of fourteen days after the insertion of this notice in the London Gazette.

WHEREAS by an Act, passed in the 8th and 9th Victoria, cap. 94, intituled "An Act for regulating the trade of the isle of Man," we, being three of the Lords Commissioners of Her Majesty's Treasury, do hereby, in pursuance of the powers vested in us by the said Act, order and declare, that all or any articles legally importable into the isle of Man, and not enumerated in the table annexed to the said Act, and upon which the duty of £15 per cent. is thereby imposed, shall and may, from and after the passing of the said before-mentioned Act, be imported into the isle of Man duty free, so long as this our order, or any part thereof, affecting such articles shall continue in force; and we do further direct, that this our order be published in the London and Dublin Gazettes, in accordance with the provisions of the 3d section of the said Act.
