

year, pay such sum or proportion, as the case may be, to the archdeacon of Buckingham for the time being; and whenever a vacancy shall happen in the said archdeaconry of Buckingham on any other than the last day of the year, the payment then next due shall be duly apportioned and paid between and to the archdeacon making the vacancy, or his representatives, and the succeeding archdeacon :

“ And whereas the Venerable Charles Carr Clerke was, at the time of the passing of the said recited Act and now is archdeacon of Oxford; we further recommend and propose, with his consent, in testimony whereof he has also signed and sealed this scheme, that the whole rectory and parsonage of Yefly otherwise Eifly otherwise Ifley, in the said diocese of Oxford, together with all lands, tithes, tenements, and hereditaments appertaining and belonging thereto, and also all other lands, tithes, tenements, and hereditaments (if any) at any time heretofore annexed to and now forming part of the endowment of the said archdeaconry of Oxford, shall, except any right of patronage, be disannexed from the said archdeaconry, and shall become and be absolutely transferred to and vested in us for the purposes of the said recited Act.

“ And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said Act, or of any other Act of Parliament.”

And whereas due notice of the said scheme has been given in accordance with the provisions of the said recited Act, and no objection has been made thereto:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Oxford.
