The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled " An Act to carry into effect, with certain " modifications, the fourth report of the " Commissioners of Ecclesiastical Duties and " Revenues;" and of another Act, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled " An Act " to explain and amend two several Acts relating " to the Ecclesiastical Commissioners for England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the thirteenth day of May, in the year one thousand eight hundred and forty-six, in the words following, that is to say ;

We, the sEcclesiastical's Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled " An Act " to carry into effect, with certain modifications, "the fourth report of the Commissioners of "Ecclesiastical Duties and Revenues;" and of another Act, passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled " An Act to explain and amend " two several Acts relating to the Ecclesiastical " Commissioners for England," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for substituting a money payment to the treasurer of Chichester cathedral church, for certain property belonging to him as such treasurer.

"Whereas, under the provisions of the said Acts, the whole of the property now belonging to the dignity or office of treasurer in any cathedral church in England (excepting any right of patronage) will, upon the first avoidance of such dignity or office, become absolutely vested in us for the purposes of the said Acts; and the chief of such purposes is that of making better provision for the cure of souls in parishes where such assistance is most required :

"And whereas it is by the same Acts enacted, that, by the authority therein provided, and for the purpose of fully carrying into effect any of the provisions thereof, any arrangement may from time to time be made, with the consent in writing under the hand of any dignitary or officer of any eathedral church, for the sale, transfer, or exchange of any lands, tithes, or other hereditaments belonging to such dignitary or officer, or for the purchase of other lands, tithes, or hereditaments in lieu thereof, or for substituting in any case any lands, tithes, or other hereditaments for any money payment,—or any money payment for any lands, tithes, or other hereditaments :

"And whereas the property now belonging to the office of treasurer in the cathedral church of Chichester consists, amongst other things, of cértain manors, messuages, lands, tithes, tenements, and hereditaments at and near Eastbourne, in the county of Sussex, which have been from time to time and now are demised by lease for lives :

"And whereas the following arrangement, for substituting a money payment for such property as aforesaid, appears to us and to the Reverend Henry Michell Wägner, the present Treasurer of the said cathedral church, to be expedient, with a view to sooner carrying into effect the purpose hereinbefore particularly mentioned; and, according to the best calculation which can now be made, we and the said Henry Michell Wagner are satisfied that such money payment should be the annual sum hereinafter mentioned to be paid by us to him during his incumbency of the said office of treasurer :

"We, therefore, with the consent of the said Henry Michell Wagner, testified by his having signed this scheme, humbly recommend and propose, that, upon and after the day on which any Order of your Majesty in Council for ratifying this scheme shall be published in the London Gazette, all manors, messuages, lands, tithes, tenements, and hereditaments whatsoever (except any right of patronage) situate, lying, and being at and near Eastbourne aforesaid, which shall have been at any time annexed to or held with, and shall now belong to, the said office of treasurer of

the said cathedral church, or to or in which he. the said Henry Michell Wagner, as such Treasurer, has, or ought to have, any right, title, or interest, together with all right, title, and interest therein, shall, without any assurance in the law other than this scheme, and such Order of your Majesty in Council so published as aforesaid, be, and be held to be, for the consideration hereafter mentioned, transferred and conveyed from and by the said Henry Michell Wagner to us, and shall then and thereupon become and be absolutely vested in us for the purposes of the said Acts, subject only to any legally subsisting lease or leases thereof or of any part or parts thereof; and that, in consideration of and for such transfer and conveyance as aforesaid, there shall be paid by us to the said Henry Michell Wagner, so long as he shall continue to hold the said office of treasurer, and no longer, the annual sum of two hundred pounds, by equal half-yearly payments, the first such payment being made on the day of the expiration of sixcalendar months next after the day of such publication as aforesaid; and that, if the next avoid= ance of the said office of treasurer shall happen on any other day than one of the two regular halfyearly days of payment, then a proportionate sum only shall be paid to the said Henry Michell Wagner, or his representatives.

" And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said recited Acts, or either of them, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Chichester.

An Act to amend two clerical errors in an Act, of the last session, for regulating the labour of children, young persons, and women, in print works.

An Act to amend an Act, of the second and third years of His late Majesty, by providing additional booths or polling places at elections in Ireland, where the number of electors whose names shall begin with the same letter of the alphabet shall exceed a certain number.

An Act to authorize certain alterations in the line of the Syston and Peterborough branch of the Midland Railway, and the formation of certain other branch railways in connection therewith.

An Act for making a railway from Maldon, through Witham, to Braintree, all in the county of Essex.

An Act for constructing and maintaining an arcade between Argyle-street and Great Clydestreet, in the city of Glasgow, to be called "The Union Arcade," and for altering the site of an intended foot passenger bridge across the Clyde, at Glasgow.

An Act to alter, amend, and enlarge the powers and provisions of an Act, passed in the second and third years of the reign of Her present Majesty, intituled "An Act for maintaining and regulating the market, in the parish of Sizimouth, in the county of Devon."

An Act for the better and more effectual ascertaining, assessing, collecting, and levying the poor rate and all other rates and assessments, in the parish of Carshalton, in the county of Surrey; and for the better management of the business and affairs of the said parish; and for other purposes relating thereto.

An Act to incorporate the members of the institution, called the "Royal Asylum of the Saint Ann's Society," and to enable them the better to carry on their charitable designs.

An Act forming and regulating "The Electric Telegraph Company," and to enable the said company to work certain letters patent.
