PRESENT,

The QUEEN's Most Excellent Majesty in Council.

THEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with " certain modifications, the fourth report of the " Commissioners of Ecclesiastical Duties and "Revenues," and of another Act, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled "An "Act to explain and amend two several Acts " relating to the Ecclesiastical Commissioners for " England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twentieth day of July one thousand eight hundred and forty-seven, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act" to carry into effect, with certain modifications, "the fourth report of the Commissioners of Eccuric clesiastical Duties and Revenues," and of another Act, passed in the session of Parliament

held in the fourth and fifth years of your Majesty's reign, intituled "An Act to explain and amend "two several Acts relating to the Ecclesiastical "Commissioners for England," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for substituting a money payment to the Treasurer of the cathedral church of Saint David's, for the property belonging to him as such Treasurer.

"Whereas, by and under the provisions of the said Acts, the whole of the separate estates and endowments belonging to the said dignity or office of Treasurer, consisting chiefly of certain tithe rent charges in the parishes of Llandesilio Gogo, otherwise Llandesseleo Gogo and Llangraynog, otherwise Llangranog, and of the hamlet of Blainbownant, in the parish of Pembryn, in the county of Cardigan (excepting any right of patronage), will, upon the first avoidance of such dignity or office, become absolutely vested in us for the purposes of the said Acts; and the chief of such purposes is that of making better provision for the cure of souls in parishes where such assistance is most required:

"And whereas it is by the same Acts enacted, that by the authority therein provided, and for the purpose of fully carrying into effect any of the provisions thereof, any arrangement may, from time to time, be made, with the consent in writing, under the hand of any dignitary or officer of any cathedral or collegiate church, for the sale, transfer or exchange of any lands, tithes or other hereditaments belonging to such dignitary or officer, or for the purchase of other lands, tithes, or other hereditaments in lieu thereof, or for substituting in any case any lands, tithes or other hereditaments for any money payment, or any money payment for any lands, tithes or other hereditaments:

"And whereas it was, on the twenty-fourth day of June last, agreed between us and the Reverend Charles Philipps, the present owner of the said tithe rent charges, as treasurer of the said cathedral church of Saint David's, that the following arrangement should be recommended by us to your Majesty in Council, with a view to sooner carrying into effect the purpose of the said Acts hereinbefore particularly mentioned:

"We, therefore, with the consent of the said Charles Philipps, testified by his having signed this scheme, humbly recommend and propose, that, without any conveyance or assurance in the law other than this scheme and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and after the day of such gazetting, all the said tithe rent charges now belonging to the said Charles Philipps as such treasurer as aforesaid, shall, together with all right, title and interest therein, be and be held to be, for the consideration hereinafter mentioned, transferred and conveyed, by and from the said Charles Philipps to us, and shall then and thereupon become and be absolutely vested in us for the purposes of the said Acts, subject only to any legally subsisting lease or leases thereof, or of any part or parts thereof, and that in consideration of and for such transfer and conveyance there shall be paid by us to the said Charles Philipps in each and every year so long as he shall continue to be treasurer of the said cathedral church, and no longer, the annual sum of one hundred and twelve pounds, by equal halfyearly payments, on the twenty-fourth day of June and the twenty-fourth day of December, the first such payment to be made on the twentyfourth day of December next; provided, that no renewal of any lease, nor any new lease, of such tithe rent charges shall since the said twenty-fourth day of June last have been or shall be made or granted by the said Charles Philipps; and that, if the next avoidance of the said

treasurership shall happen on any other day than one of such two half-yearly days of payment, then a proportionate sum only shall be paid to the said Charles Philipps or his representatives.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said recited Acts, or either of them, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Saint David's.

twentieth day of July, in the year one thousand eight hundred and forty-seven, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for " carrying into effect the reports of the Com-" missioners appointed to consider the state of the " Established Church in England and Wales, " with reference to ecclesiastical duties and " revenues, so far as they relate to episcopal "dioceses, revenues, and patronage;" and of another Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry into " effect, with certain modifications, the fourth re-" port of the Commissioners of ecclesiastical duties " and revenues;" have prepared, and now humbly lay before your Majesty in Council, the following scheme, for newly arranging the rural deanries within the archdeaconry of Bath, and for abolishing peculiar and exempt jurisdictions in the diocese of Bath and Wells.

"Whereas it was by the first recited Act provided, that the limits of the then existing deanries and archdeaconries should be newly arranged, so that every parish and extra parochial place should be within a rural deanry, and every deanry within an archdeaconry:

"And whereas it was by the same Act enacted, that it should be competent to us to propose, in any scheme prepared and laid before your Majesty in Council under the provisions thereof, that all parishes, churches or chapelries locally situate in any diocese, but subject to any peculiar jurisdiction other than the jurisdiction of the bishop of the diocese in which the same were locally situate, should be only subject to the jurisdiction of the bishop of the diocese in which the same were locally situate:

"And whereas it was by the secondly recited Act enacted, that in any case in which it should appear, upon the representation of the bishop of the diocese, to be proper to divide any rural deanry on account of the magnitude thereof, or of any other peculiar circumstances connected therewith, such rural deanry might, by the authority therein provided, be divided into two or more

portions, and each of such portions might be constituted a separate rural deanry, as the case might be, and a district assigned thereto; provided always, that no such division should be made without the consent of the bishop of the diocese, under his hand and seal:

"And whereas it has been represented to us by the Honourable and Right Reverend Richard Bishop of Bath and Wells, that the rural deanries of Bath and Redcliffe and Bedminster, comprising the whole of the said archdeaconry of Bath, are now inconveniently arranged; and it appears to the said bishop, and to us, to be expedient and proper that such rural deanries should be newly arranged and divided as hereinafter mentioned; and that by reason of the parish of Bedminster having been transferred and united to the diocese of Gloucester and Bristol, the name and title of the rural deanry of Redcliffe and Bedminster should be changed, and that such rural deanry should hereafter be named the Rural Deanry of Chew:

"We, therefore, humbly recommend and propose, with the consent of the said Richard Bishop of Bath and Wells, in testimony whereof he has signed and sealed this scheme, that the said rural deanry of Bath and the rural deanry now styled the Rural Deanry of Redcliffe and Bedminster, which we recommend and propose shall be hereafter named the Rural Deanry of Chew, shall be respectively newly arranged and divided, and that each of such rural deanries shall respectively henceforth comprise and consist of the several parishes and districts mentioned and set under or against the name of each of such rural deanries, as the same are respectively set forth in the schedule hereunto annexed.

"And we further recommend and propose, that upon and after the twenty-first day next following the day upon which any Order of your Majesty in Council, ratifying this scheme, shall be published in the London Gazette, all parishes and places then locally situate within the limits of the said diocese of Bath and Wells, and of the several archdeaconries thereof respectively, and all churches and chapels, and the whole clergy and others your Majesty's subjects locally situate within the limits of such parishes and places respectively, shall, notwithstanding any peculiar or other ecclesiastical jurisdiction or exemption from

furisdiction which any of such parishes, places, churches, chapels or clergy may possess or be subject to, or claim to possess or be subject to, be respectively under and subject only to the jurisdiction and authority of the Bishop of Bath and Wells, and of the archdeacons of the several archdeaconries of the said diocese of Bath and Wells, within the limits of which they shall respectively be so locally situate, except the cathedral church of Wells which shall remain and be subject to the jurisdiction and visitation to which the same is now by law subject and to none other; and we further recommend and propose that, with the like exception, all and each of such parishes, places, churches and chapels, so possessing or being subject to, or claiming to possess or be subject to, any such peculiar jurisdiction or exemption from jurisdiction, and all other parishes, places, churches and chapels locally situate within the diocese of Bath and Wells, shall severally and respectively be included in and form part of the said diocese, and of the archdeaconries and rural deanries thereof respectively, within the limits of which they shall respectively be locally situate.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said Acts, or of any other Act of Parliament.

" SCHEDULE.

" No. 1. The RURAL DEANRY OF BATH, comprising -

" The several parishes, districts and churches of Saint Peter and Saint Paul, or the Abbey with Saint James, Bath, and Widcombe, and Saint Mark in Widcombe, and Saint Matthew's in Widcombe, and Saint Michael, Bath, Bathampton with Bathford, Batheaston with Saint Catherine, Bathwick with Woolley, Brislington, Burnett, Charlcombe, Claverton, Coombe Down, Corston, Englishcombe, Farmborough, Freshford, Langridge, Marksbury, Kelston, Keynsham, Monkton Coombe, Newton Saint Loe, North Stoke, Priston, Queen Charlton, Saltford, South Stoke, Stanton Prior, Swainswick, Timsbury, Tiverton, Walcot Saint Swithin, Walcot Christchurch, Walcot Saint Saviour, Walcot Trinity, and Weston with Saint John Weston.

No. 2. The RURAL DEANRY OF CHEW, comprising—

The several parishes, districts and churches of Abbots Leigh, Backwell, Barrow Gurney, Brockley, Burrington, Butcombe, Chelwood, Chelvey, Chew Magna with Dundry and Bishop's Sutton, Chew Stoke, Clapton, Clevedon Saint Andrew, Clevedon Christchurch, Cleve in Yatton, Clutton, Compton Dando, Compton Martin with Nempnett, Easton in Gordano, Flax Bourton, Henton Bluett, High Littleton, Kenn, Kingston Seymour, Long Ashton, Nailsea Trinity, Nailsea Christchurch, Norton Malreward, Portbury with Tickenham, Portishead, Publow, Stanton Drew with Pensford, Stowey, Ubbley, Walton in Gordano, West Harptree, Weston in Gordano, Whitchurch, Winford, Wraxall, Wrington with Redhill, and Yatton."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Bath and Wells."

The QUEEN's Most Excellent Majesty in Council.

HEREAS an Act was passed in the fiftyninth year of the reign of His late Majesty King George the Third, intituled "An Act to "carry into effect a convention of commerce "concluded between His Majesty and the United "States of America, and a treaty with the Prince "Regent of Portugal," whereby, after reciting certain provisions contained in certain treaties or conventions, made between His said late Majesty and the United States of America, and between His said late Majesty and the Prince Regent of Portugal, divers provisions were made respecting the duties payable and the bounties and allowances to be granted upon the importation and exportation of goods, wares, and merchandize into or from the United Kingdom in vessels of the United States and in Portuguese vessels, and respecting the repayment to certain corporations, bodies politic and corporate, and sundry other persons, of the amount of the sums of money of which they would be deprived by means of the said Act:

And whereas by an Act, passed in the session of Parliament holden in the eighth and ninth years of the reign of Her present Majesty, "An Act for granting duties intituled "Customs," it is, amongst other things, enacted and declared, that, from and after the ratification of any treaty heretofore made by Her Majesty, and any of Her royal predecessors, subsequently to the said first hereinbefore recited Act, or of any treaty which may be reafter be made by Her Majesty, Her heirs and successors, with any foreign power, in which treaty have been or shall be contained provisions similar to those recited in the said first hereinbefore recited Act, all and every the provisions, clauses, matters, and things in the said first hereinbefore recited Act contained, shall apply and extend to the trade and shipping of such foreign powers, respectively, as fully and effectually to all intents and purposes as to the trade and shipping of the said United States and of the said kingdom of Portugal, and also shall apply and extend to differential duties or charges on goods imported or exported in the ships of such foreign powers as well as to differential duties on the ships of such foreign powers:

And whereas by the last recited Act it is further enacted, that it shall and may be lawful for Her Majesty, Her heirs and successors, by any Order or Orders to be by Her or them made with the advice of Her or their Privy Council, and published in the London Gazette, from time to time to declare what are the foreign powers with which any such treaty or treaties aforesaid is or are subsisting, and that the said recited Acts shall apply and shall be deemed, from the time of the ratification of any such treaties, to have been applicable to the trade and shipping of such foreign countries as shall be so mentioned in any such Order or Orders in Council as aforesaid, so long as any such Order or Orders shall continue unrevoked, and no longer:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and, in pursuance and exercise of the powers vested in Her by the said Act of the eighth and ninth years of Her Majesty's reign, doth hereby declare, that a treaty has been concluded and is now subsisting between Her Majesty and His Imperial and Royal Highness the Grand Duke of Tuscany:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions herein accordingly.

HEREAS by an Act, passed in the session of Parliament held in the first year of Her Majesty's reign, intituled "An Act to amend an "Act for the regulation of municipal corporations in England and Wales," it is, amongst other things, enacted, that if the inhabitant householders of any town or borough in England or Wales shall petition Her Majesty to grant to them a charter of incorporation, it shall be lawful for Her Majesty, by any such charter, if she shall think fit, by the advice of Her Privy Council, to grant the same, to extend to the inhabitants of any such town or borough, within the district to be set forth in such charter, all the powers and provisions of the Act of the fifth and sixth William the Fourth, cap. 76, for regulating corporations, whether such town or borough be or be not a corporate town or borough, or be or be not named in either of the schedules to the said Act; provided, nevertheless, that notice of every such petition, and of the time when it shall please Her Majesty to order that the same be taken into consideration by Her Privy Council, shall be published in the London Gazette. one month at least before such petition shall be so considered :

And whereas the inhabitant householders of the borough of Wakefield, in the west riding of the county of York, have presented a petition to Her Majesty in Council, praying, that a charter of incorporation may be granted to the said borough; Her Majesty was this day pleased to order, and it is hereby ordered, that the said petition be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on Saturday the twenty-eighth day of August next.
