The Queen taking into Her royal consideration that, upon the decease of William-Thomas Baron Say and Sele, without issue (which happened on or about the 31st day of March 1847), the title and dignity of Baron Saye and Sele devolved upon Frederick-Benjamin Twisleton, now Baron Saye and Sele, as the eldest surviving son and heir of the late Thomas-James Twisleton, commonly called the Honourable and Reverend Thomas-James Twisleton, D.D. sometime Archdeacon of Colombo, in the island of Ceylon, deceased; whilst living the second son of Thomas Baron Saye and Sele, and next brother of Gregory-William Baron Saye and Sele, father of the said William-Thomas late Baron Saye and Sele, and that, according to the ordinary rules of honour, the younger children of the said Thomas-James Twisleton cannot enjoy that place and precedence which would have been due to them in case their said late father had survived his nephew, the said William-Thomas late Baron Saye and Sele, and had thereby succeeded to the title and dignity of Baron Saye and Sele; Her Majesty hath been graciously pleased to ordain and declare, that Charles-Samuel Twisleton, Clerk, Master of Arts, Rector of Ashow, in the county of Warwick, Edward-Boyd-Turner Twisleton, Esquire, Chief Commissioner of Poor Laws in Ireland, and Mary-Elizabeth, widow and relict of the late William Gisborne, Esquire, of the Civil Service in the island of Ceylon, the younger sons and daughter of the said Thomas-James Twisleton; and brothers and sister of the said Frederick-Benjamin now Baron Saye and Sele, shall hence-
