

The Queen has been pleased to grant unto Hugh-Henry Rose, Esq. a Lieutenant-Colonel in the Army, and Companion of the Most Honourable Order of the Bath, Her Majesty's Consul-General in Syria, Her royal licence and permission, that he may accept and wear the Cross of the Prussian Order of St. John of Jerusalem, which His Majesty the King of Prussia hath been pleased to confer upon him, in approbation of the services rendered by that officer in the course of the Campaign in Syria, in the year 1841, and particularly for his distinguished conduct in the engagement which took place near Mejdel on the 15th day of January in that year: Provided, nevertheless, that this licence and permission doth not authorize the assumption of any style, appellation, rank, precedence, or privilege, appertaining unto a Knight Bachelor of these realms.

And also to command, that this Her Majesty's concession and especial mark of Her Royal favour be registered, together with the relative documents, in the College of Arms.

Whereas, by date the fifteenth day of January one thousand eight hundred and forty-nine, We, the General Board of Health, issued an Order "To the Parochial Board for the management of the poor in the Barony parish, Glasgow," and in such Order we directed, "that a sufficient number, both of houses of refuge and of hospitals, be opened forthwith, provided with the necessary means of affording relief, whether medical or otherwise, and also provided with the proper number of nurses for attending on the sick night and day;" and whereas an hospital was opened at Woodside, Glasgow, for the reception of cholera patients, and provided with medical and other attendants; and whereas we have been informed, that the disease has so far abated that the services of such attendants are no longer necessary. We, the General Board of Health, do hereby authorize that such service be henceforth discontinued; provided always, that the hospital, with all its furniture and fixtures be retained as at present: and that, in case of a fresh outbreak of the disease, the said hospital shall be immediately re-opened for the reception of all cases happening in the locality where it is situated.
