in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to " amend and render more effectual an Act, passed " in the last session of Parliament, for building, " and promoting the building of additional churches "in populous parishes," or under or by virtue of any other power or authority vested in them by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the thirteenth day of March one thousand eight hundred and forty-nine, in the

words following; that is to say:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that having taken into consideration all the circumstances of the parish of Pleasley, in the county of Derby, and within the diocese of Lichfield, it appears to them to be expedient that a particular district should be assigned to the consecrated church of the holy and undivided Trinity, situate at Shirebrook, in the said parish of Pleasley, under and by virtue of the power or authority for such purpose contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in the last session of Parliament, for 'building, and promoting the building of addi-'tional churches in populous parishes,' or under 'tional churches in populous parishes, or by virtue of any other power or authority in this behalf vested in your Majesty's said Commissioners by the Church Building Acts, and that such proposed district should be named 'The Chapelry District of Shirebrook,' with boundaries as hereinafter mentioned:

"The proposed chapelry district of Shirebrook commences at the south-west corner of the chapelry, at the point where the parishes of Pleasley and Mansfield Woodhouse meet at the river Meden, and proceeds in an eastwardly direction along the boundary of the parish of Mansfield Woodhouse, which is principally by the course of the river Meden; thence in a north-wardly and north-eastwardly direction along the boundary fence of Sookholme township to and across Wood-lane, leading from Pleasley to Sookholme; thence in a north-westwardly direction along the said boundary fence to and across the bridle-road leading from Shirebrook to Sookholme; thence in a northwardly direction along the said boundary fence to and across a carriage-road leading from Shirebrook to Warsop; thence in a north-westwardly and westwardly direction along the said boundary fence to a point where the townships of Sookholme and Warsop divide; thence in a northwardly direction along the boundary fence of Warsop to a point where the parishes of Warsop and Upper Langwith divide; thence in a westwardly, north-westwardly, northwardly and south-westwardly direction, along the boundary fence of Upper Langwith to the public carriage road leading from Upper Langwith to Pleasley; thence in a south-westwardly direction along the said road and boundary of Upper Langwith to the junction with the public carriage-road leading from Shirebrook to Stoney Houghton; thence in a northwardly and westwardly direction along the said boundary of Upper Langwith to a point which divides that parish from the township of Stoney Houghton; then in a southwardly direction along the boundary fence of Stoney Houghton the said public carriage-road leading from Shirebrook to Stoney Houghton; thence in a westwardly direction along the said road and boundary, and proceeds in a southwardly direction along the said boundary fence to the public car-

riage-road leading from Stoney Houghton to Sookholme; thence in a south-westwardly direction along the said road and boundary to a point which divides the townships of Stoney Houghton and Pleasley; thence proceeds in the same direction along the said road which crosses the road leading from Upper Langwith to Pleasley, along the boundary of the township of Pleasley; and in a south-eastwardly direction along the said road and boundary to the north-east corner of Pleasleypark; and thence proceeds in a southwardly and south-eastwardly direction along the said boundary fence to, and terminating at, the river Meden, at the south-west corner of the said chapelry, as such proposed chapelry district of Shirebrook is more particularly delineated on the map or plan hereunto annexed, and thereon coloured green:

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that it also appears to them to be expedient, that banns of marriage should be published, or continue to be published in the said church at Shirebrook aforesaid, and that marriages, baptisms, churchings and burials, should also be solemnized or performed, or continue to be solemnized or performed in the said church at Shirebrook aforesaid, and that all the fees to arise therefrom should be paid and belong to the minister or incumbent thereof

for the time being:

"That the consent of the Right Reverend John Bishop of Lichfield (as the Bishop of the diocese) has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof, the said John Bishop of Lichfield has

signed and sealed this representation:

'Your Majesty's said Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made; and the recommendations of the said Commissioners, in respect of the publication of banns, and the solemnization of marriages, baptisms, churchings and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Lichfield.
