WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act "to amend and render more effectual an Act, passed "in the last session of Parliament, for building and "promoting the building of additional churches in "populous parishes," or under or by virtue of any other power or authority vested in them by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-seventh day of February, one thousand eight hundred and fortynine, in the words following; that is to say:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty that, having taken into consideration all the circumstances of the parish of Barwick in Elmet, in the West Riding of the county of York, and within the diocese of Ripon, it appears to them to be expedient that a particular district should be assigned to the consecrated church of Saint James, situate at Manston, in the said parish of Barwick in Elmet, under and by virtue of the power or authority for this purpose contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend 'and render more effectual an Act passed in the last session of Parliament for building and promoting the building of additional churches ' in populous parishes,' or under or by virtue of any other power or authority in this behalf vested in your Majesty's said Commissioners by the Church Building Acts, and that such proposed district should be called 'The Chapelry District of Manston', with boundaries as hereinafter mentioned :

"The first portion of the proposed chapelry district of Manston is bounded on the north by the township of Shadwell, in the parish of Thorner; on the north-west by the township of Roundhay, in the said parish of Barwick in Elmet; on the west by the chapelry district of Searoft, in the parish of Whitkirk; on the south by the said chapelry district of Seacroft, and parish of Whitkirk; on the east by the remaining part of the parish of Barwick in Elmet, from which the proposed chapelry district of Manston is separated by a stream called Cock Beck, up which said stream the boundary of such last-mentioned district proceeds north-westerly to the source thereof, and from that point in a straight line

northerly to a bound-stone placed on the borders of the said parishes of Barwick in Elmet and Thorner; the second and remaining portion of the said proposed chapelry district of Manston is situated south-eastwardly of the first portion thereof, and is bounded on the west by the beforementioned chapelry district of Seacroft and parish of Whitkirk; on the south by the parish of Swillington; on the south-east by the parish of Garforth; on the north-east by part of the parish of Barwick in Elmet, from which the said proposed chapelry district of Manston is separated by a line drawn in a northerly direction from a bound-stone placed on the borders of the said two parishes of Garforth and Barwick in Elmet, to another bound-stone placed on the southern side of the stream called Cock Beck ; and on the north by the said stream called Cock Beck, which separates such proposed chapelry district of Manston from the remaining part of the said parish of Barwick in Elmet, and which two portions forming the said proposed chapelry district of Manston, are more particularly delineated on the map or plan hereunto annexed, and are thereon respectively coloured pink :

"And your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed in the said church of Saint James, at Manston aforesaid, and that the fees to arise therefrom should be paid and belong to the incumbent or minister of such church for the time being:

"That the consent of the Right Reverend Charles Thomas Lord Bishop of Ppon (as the Bishop of the diocese) has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof the said Charles Thomas Lord Bishop of Ripon has signed and sealed this representation:

"Your Majesty's said Commissioners, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."
