Thomas Edgerley, formerly of Sheppenhall-hall, near Wrenbury, in the county of Chester, Farmer, and late of Davenham, near Northwich, in the said county, out of business.

Thomas Hyde, formerly of Mill-street, Macclesfield, in the county of Chester, Foreman to a Tailor and Woollendrapery, then of Mill-street, Macclesfield aforesaid, Tailor and Woollendrapery, and late of Uttoxeter, in the county of Stafford, in lodgings, out of business, part of the time whilst residing in Mill-street, Macclesfield aforesaid, having had a shop in the Market-place, Leek, in the county of Stafford, for the sale of Wearing Apparel.

John Davies, formerly of Garth Ucha, near Oswestry, in the county of Salop, part of the time holding a farm and cottage at Pentre Sychtyn, and also a farm at Bryn-y-vedwen, both places near Oswestry aforesaid, then of Bryn-y-vedwen aforesaid, Farmer, under the name of Samuel Morgan, and late of Lower Bridge-street, in the city of Chester, in lodgings, out of business.

Randle Bower, formerly of Heyrod, near Staley-bridge, in the county of Lancaster, carrying on business in Partnership with his late brother Judson Bower, as Cotton Spinners, under the firm of Randle and Judson Bower, having a mill at Blackrock, near Staley-bridge aforesaid, then of Heyrod aforesaid, and having the mill at Black-

rock aforesaid, Cotton Spinner, afterwards having a factory at Heyrod, and at Blackrock aforesaid, at both these last places carrying on business as a Cotton Spinner, on his own account, during all these periods occasionally dealing in Sheep, afterwards of Wilshaw, near Ashton-under-Lyne, in the county of Lancaster, and late of Woodhead, near Mottram, in Longdendale, in the county of Chester, in both last-mentioned places Cattle and Sheep Dealer.

Samuel Lockett, formerly of the Ryles Arms, near Watercoats, in the borough of Macclesfield, in the county of Chester, Licensed Victualler, and late of High-street, Sutton, in the said borough of Macclesfield, in lodgings, and out of business.

Samuel Lees, formerly of Micklehurst, near Mottram, in Longdendale, in the county of Chester, Cotton-waste Dealer, and late of the same place, in lodgings, out of business.

James Mullin, formerly of Liscard, in the county of Chester, Beer-house Keeper and Dealer in Tobacco, at the same time a Tailor, and late of Liscard aforesaid, Licensed Victualler.
