THEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to "amend and render more effectual an Act passed "in the last session of Parliament, for building "and promoting the building of additional churches "in populous parishes," or under or by virtue of any other power or authority vested in them by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the twentieth day of June one thousand eight hundred and forty-nine, in the words following; that is to say:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that, having taken into considera-tion all the circumstances of the parish of Mid-somer Norton, in the county of Somerset, and within the diocese of Bath and Wells, it appears to them to be expedient that a particular district should be assigned to the consecrated church of the Holy and Undivided Trinity, situate at Clandown, in the said parish of Midsomer Norton, under and by virtue of the power or authority for this purpose contained in the sixteenth section of an Act passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled, 'An Act to amend and render more effectual an 'Act passed in the last session of Parliament for building and promoting the building of additional churches in populous parishes," or under or by virtue of any other power or authority in this behalf vested in your Majesty's said Commissioners by the Church Building Acts, and that such proposed district should be named 'The Chapelry District of Clandown,' with boundaries as hereinafter mentioned:

" The chapelry district of Clandown is bounded on the west by the parish of Paulton, on the north by the parish of Timsbury, on the northeast and east by the parish of Camerton, on the south-east by the parish of Radstock, and on the south by the remaining part of the said parish of Midsomer Norton, from which such proposed district is separated as follows: namely, by a line proceeding westerly from the said parish of Radstock, along the northern side of the stream or brook as far as the south eastern corner of Home Mead, marked No. 288 on the Tithe Commutation Map of the said parish of Midsomer Norton; then

northerly up the eastern enclosure thereof to the railroad; thence westerly along the northern side of the said railroad, as far as enclosure No. 239 (B), and across that enclosure and also that of No. 237, to the point marked A on the western side of the road leading to Welton Hill Colliery, and from that point southerly down the western side of that road to the road leading from Welton to Farrington; and then westerly, along the northern side of the latter road, as far as the said parish of Paulton, as such proposed chapelry district of Clandown is more particularly delineated on the map or plan hereunto annexed and thereon coloured green:

" Your Majesty's said Commissioners beg leave further to represent to your Majesty that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, churchings, and burials should be solemnized and performed in the said church, at Clandown aforesaid, and that the fees to arise therefrom should be paid and belong to the incumbent

thereof for the time being:

"That the consent of the Honourable and Right Reverend Richard Lord Bishop of Bath and Wells (as the Bishop of the diocese) has been obtained thereto, as required by the Act and section hereinbefore mentioned, in testimony whereof the said Richard Lord Bishop of Bath and Wells has signed and sealed this representation:
"Your Majesty's said Commissioners therefore

humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."
