

and consequent incorporation for the purposes of the said deed, and to enable the said Company to light with gas the City of London and the Liberties thereof, and also the several parishes, townships, hamlets, precincts, liberties, and extra-parochial and other places following, or some part or parts thereof; that is to say:—The parish of Bromley St. Leonard; the parish of St. Mary, Stratford, Bow; the parish of St. Anne, Limehouse; the hamlet of Ratcliff; the hamlet of Mile-end Old Town; the hamlet of Mile-end New Town; the hamlet of Spitalfields; the parish of St. Dunstan, Stepney, otherwise Stebon-heath, Ratcliff; the parish of St. Paul, Shadwell; the parish of St. George, otherwise called St. George in the East; the parish of St. Botolph without, Aldgate; the parish of St. Mary, Whitechapel, otherwise St. Mary Matfelon; the parish of Christchurch, otherwise called Christ Church, Spitalfields; the parish of the Trinity, Minorities, otherwise called the parish of the Holy Trinity, Minorities; the parish of St. Peter ad vincula, within the Tower of London; the liberty of the Tower without, otherwise called the liberty of the Old Tower without; the parish of St. Matthew, Bethnal Green; the parish of St. Leonard, Shoreditch; the liberty of Norton Folgate; the liberty of the Old Artillery Ground; the parish of St. Pancras; the parish of St. Luke, otherwise St. Luke, Old Street; the liberty of Glasshouse Yard, and the parish of St. Botolph without, Aldersgate; the parish of St. Sepulchre; the parish of St. John, Clerkenwell; the liberty of the Charterhouse; the parish of St. James, Clerkenwell; the parish of St. Mary, Islington; the united parishes of St. Andrew, Holborn above Bars, and St. George the Martyr, otherwise called the parish of St. Andrew, Holborn above Bars, and the parish of St. George the Martyr, Queen's Square; the liberty of the Rolls; the liberty or liberties of Saffron Hill, Hatton Garden, and Ely Rents, and the township or district of Gray's Inn, all which said parishes, townships, hamlets, precincts, liberties, and extra-parochial and other places are situate within the county of Middlesex; and also to enable the said Company to supply gas, both for public and private consumption, within and throughout all the limits aforesaid. And it is also intended by the said Act to restrain the said Company from charging for the gas supplied by them any sum exceeding four shillings for every 1,000 cubic feet. And it is also intended to incorporate in the said Act the "Companies' Clauses' Consolidation Act, 1845," the "Gas Works' Clauses' Act, 1847," and the "Lands' Clauses' Consolidation Act, 1845," save and except such portions of the said last-mentioned Act as relate to the purchase and taking of lands otherwise than by agreement. And it is also intended by the said proposed Act to confer upon the said Company all necessary powers for

the purposes aforesaid, and for enabling the said Company to manufacture and purchase gas, and to make, erect, and construct all gasholders, retorts, receivers, buildings, engines, and other works, and to lay down mains, pipes, and other apparatus necessary for the manufacture, storing, and supply of gas, and for other the purposes of the said proposed Act, and to agree with the owners of any lands within the limits aforesaid, to purchase or lease the same for the purposes of the said works, provided that the said Company shall not be empowered to manufacture gas within the city of London or the liberties thereof; and it is also intended by the said proposed Act to authorize the said Company to receive and recover rents and charges for the supply of gas within the limits aforesaid; and it is also intended by the said proposed Act to authorize the appointment of one or more inspectors of the meters used in measuring the gas supplied by the said Company, and also of one or more skilled persons to test the quality of the said gas; and also of one or more auditors of the accounts of the said Company; and it is also intended by the said Act to vary or extinguish all existing rights or privileges, if any, which would impede or interfere with the objects aforesaid. And it is also intended by the said Act to amend, enlarge, extend, or repeal some of the powers and provisions of the Acts local and personal following, or some of them; that is to say: the 52nd Geo. 3, c. 195; the 53rd Geo. 3, c. 32; the 56th Geo. 3, c. 85; the 59th Geo. 3, c. 66 and 111; the 1st and 2nd Geo. 4, c. 43; the 5th Geo. 4, c. 47; and the 7th Geo. 4, c. 140; and all other Acts recited in the last-mentioned Acts, or in either of them, and all which relate to the Regent's Canal, and the local and personal Acts following; that is to say: an Act passed in the 7th year of King William the IVth, entitled "An Act for making a railway from the Minorities to Blackwall, with branches, to be called 'The Commercial Railway,'" and the several other Acts relating to the said railway, passed in the first, third, fourth, fifth, and ninth, and tenth years of the reign of Her present Majesty, and the London and Blackwall Railway Extension Act, 1845; the London and Blackwall Railway Improvement and branches to Saint Katherine's and London Docks' Act, 1848; the London and Blackwall Railway Amendment Act, 1848; and the London and Blackwall Railway Amendment and Extension of time Act, 1849; all which relate to the Blackwall Railway.—Dated this 17th day of November 1849.
