"That the consent of the Right Honourable and Most Reverend Thomas the Archbishop of the said diocese of York has been obtained thereto, as required by the Act and section herein-before mentioned: in testimony whereof he has signed and sealed this representation :

"Your Majesty's said Commissioners therefore. humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom. shall seem meet."

Her Majesty having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made, and the recommendations of the said Commissioners in respect of the publication of banns, and the solemnization of marriages, baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith enrolled, pursuant to the said Acts, and registered by the Registrar of the C. C. Greville. diocese of York.
