REGULATIONS TO BE OBSERVED AT THE QUEEN'S LEVEE, AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen, who purpose to attend Her Majesty's Levee, at St. James's-Palace, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with the Queen's Page in Attendance in the Presence-chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

Those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be sent in to the Lord Chamberlain's Office, on Monday, 24th March, *before twelve o'clock*, in order that they may be submitted for the Queen's approbation; it being Her Majesty's command, that no presentation shall be made at the Levee but in conformity with the above regulations.

It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to the Queen.

The state apartments will not be open for the reception of Company coming to Court, until halfpast one o'clock.

Some irregularities having taken place, notice is hereby given, that no Officer of the Army or Navy, nor any Civilian, to be presented to the Queen at the Levee, can be admitted to the state apartments for that purpose, whose presentation card has not been previously sent to the Lord Chamberlain's Office according to the above regulations.

The name of any Gentleman not adhering to the regulation, must be excluded from the presentation book, and the reason entered for so doing; viz.—The contravention of the regulations.

Notice is hereby given, that all persons having Petitions or Addresses to present to Her Majesty at the Levee, are to send a card (having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come) to the Lord Chamberlain's Office, before twelve o'clock, on Monday, 24th March next; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee; one of the two cards to be delivered to the Page in the Ante-Room, and the other to the Lord Chamberlain, who will read its contents to Her Majesty; and, on these occasions, no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled 'An Act 'to carry into effect, with certain modifications, 'the fourth report of the Commissioners of Eccle-'siastical Duties and Revenues,' and of another Act passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled 'An Act to explain and amend two 'several Acts relating to the Ecclesiastical Com-'missioners for England,' have prepared, and now humbly lay before your Majesty in Council, the following scheme for substituting a money payment to the prebendary of Bishop's Norton, in the cathedral church of Lincoln, for the property belonging to his prebend :

"Whereas, by and under the provisions of the said Acts, the whole of the separate estates and endowments belonging to the said prebend will (excepting any right of patronage), upon the first avoidance of the said prebend, become absolutely vested in us, for the purposes of the said Acts, and the chief of such purposes is that of making better provision for the cure of souls in parishes where such assistance is most required :

"And whereas it was by the same Acts enacted, that by the authority therein provided, and for the purpose of fully carrying into effect any of the provisions thereof, any arrangement might from time to time be made, with the consent in writing under the hand of any prebendary of any cathedral church, for the sale, transfer, or exchange of any lands, tithes, or other hereditaments belonging to such prebendary, or for the purchase of other lands, tithes, or other hereditaments in lieu thereof, or for substituting, in any case, any lands, tithes, or other hereditaments for any money payment, or any money payment for any lands, tithes, or other hereditaments :

"And whereas is has been agreed between us and the Reverend Frederick Borradaile, Master of Arts, the present prebendary of the said prebend that, with a view to sooner carrying into effect the purpose of the said recited Acts hereinbefore particularly mentioned, the following arrangement should be recommended by us to your Majesty in Council:

"We therefore, with the consent of the said Frederick Borradaile, testified by his having signed this scheme, humbly recommend and propose, that, without any conveyance or assurance in the law, other than this scheme and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and after the day of such gazetting, all lands, tithes and other hereditaments whatsoever (except any right of patronage) now belonging to the said prebend of Bishop's Norton as aforesaid, or to or in which he has or ought to have any estate, right, title or interest, shall, together with all such estate, right, title, and interest therein (except as aforesaid), be and be held to be, for the consideration hereinafter men-

tioned, transferred, and conveyed by and from the said Frederick Borradaile to us, and shall then and thereupon become and be absolutely vested in us, for the purposes of the said Acts, subject only to any legally subsisting lease or leases thereof, or of any part or parts thereof; and that, in consideration of and for such transfer and conveyance, there shall be paid by us to the said Frederick Borradaile so long as he shall continue to be the prebendary of the same prebend, and no longer, the annual sum of one hundred and thirty pounds by equal half yearly payments, on the first day of May and the first day of November in every year, and that a proportionate part of the first such half-yearly payment, calculated from the first day of this instant month of March, shall be made on the first day of May next: provided that no renewal of any lease, nor any new lease, of the said lands, tithes, or other hereditaments, or of any part thereof, shall since the thirty-first day of August in the year one thousand eight hundred and eleven, have been or shall be granted or made by the said Frederick Borradaile, or any of his predecessors, prebendaries of the said prebend; and that if the next avoidance of the said prebend shall happen on any other day than one of the said two half-yearly days of payment, then a pro-portionate sum only shall be paid to the said Frederick Borradaile, or his representatives :

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said recited Acts or either of them, or of any other other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Lincoln. W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the sixth day of March, in the year one thousand eight hundred and fifty one, in the words following ; that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled 'An Act 'to make better provision for the spiritual care of 'populous parishes,' have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale of certain property formerly belonging to the prebend of Litton, in the cathedral church of Wells, and now vested in us.

"Whereas it is by the said Act (amongst other things) enacted, that notwithstanding the charge by that Act created (being a charge created in favour of the Governors of the Bounty of Queen Anne), all the same and the like powers and rights of ownership as are possessed and enjoyed respect-ing and over any lands, tenements, or other hereditaments whatsoever, by any absolute owner thereof, shall be enjoyed by us with respect to and over all or any lands, tithes, rent-charges, tenements, or other hereditaments vested in us under certain Acts therein mentioned (being the Acts under which the property hereinafter described is vested in us), and may, subject to the provisions of the same Acts, and of the now reciting Act, be exercised by us, by proper instruments in writing duly executed according to law, with a certain proviso respecting the application of every sum of money received as the consideration or purchasemoney for the sale, transfer, and conveyance by us of any of such lands, tithes, tenements, or other hereditaments, or of any estate or interest therein, and with a further proviso that none of such lands, tithes, tenements, or other hereditaments be sold, transferred or conveyed, except by the authority of a Scheme, and an Order issued by your Majesty in Council ratifying the same :

"And whereas all the lands, tenements, hereditaments, and endowments (excepting any right of patronage) formerly belonging to the said prebend of Litton, became vested in us on the vacancy of the said prebend, subject to any legally subsisting lease or leases thereof:

"And whereas application has been made to us for the purchase of our estate and interest in certain portions of the said lands, tenements, and hereditaments; and after due consideration it appears to us to be expedient that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as shall appear to us to be advisable : "We, therefore, humbly recommend and pro-

pose that we may be authorized and empowered, by deed or deeds duly executed under our common seal, from time to time to sell and duly to convey, according to the provisions of the said Act, all or any of the said lands, tenements, and hereditaments (except as aforesaid), heretofore belonging to the said prebend, with their appurtenances, and all our estate, right, title and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs or assigns, or otherwise, as he or they shall direct or appoint, and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable :

" And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London | 1851, as stated in the Gazette of 14th instant.

#### GENERAL ORDER.

#### Horse Guards, 21st March, 1851.

The Queen having been pleased to signify her assent to a measure, which has been proposed by the Court of Directors of the East India Company, of granting a Medal to the surviving Officers and Soldiers of the Crown, who were engaged in the services in India enumerated in the accompanying list:—

Officers and Soldiers, who consider that they may have a claim to receive such Medal, are each to apply,—the General Officers, through the Secretary of the Commander-in-Chief of the Army;—

The Staff Officers, through the General Officers under whom they served,—if alive,—if not alive, through the Adjutant General of the Army;—

Officers, Non-Commissioned Officers, and Soldiers of Her Majesty's regiments, battalions, and detachments, through the Commanding Officer of the regiment, battalion, or detachment, at the time, if still alive. This will be known by enquiry at the agents of the regiment resident in London. If such Commanding Officer should not be alive, the application in writing must be made through the Adjutant General of the Army.

The Board of General Officers is hereby, by Her Majesty's Command, directed to take into consideration,—to investigate,—the facts stated in each of these several applications, and to report to the Commander-in-Chief upon the same, for the information of Her Majesty, in order that the Medals may be delivered to the Claimants accordingly.

The Adjutant General, and the Military Secretary to the Commander-in-Chief, will transmit to the Secretary to the Board of General Officers such information as they may have been able to acquire, to assist in the investigations which the Board will have to make; and Her Majesty has been graciously pleased to command that the departments of the Secretary at War, and of the Paymaster General, may furnish to the Board such information as the records of those Departments, respectively, can furnish, of the names of those serving with the Troops of the Crown in India at the periods, of the several achievements specified.

The Commander-in-Chief has been required to desire, that the Board of General Officers will have alphabetical lists made out of the names of the claimants to one of these Medals, together with their rank, and the names of the particular battles or sieges at which they may have been present.

It having moreover been represented to Her Majesty, that the Officers and Soldiers of the Crown who were engaged in the Mysore war, and at the sicge of Seringapatam, have already received Medals from the East India Company for those services, Her Majesty has further been graciously pleased to permit the same to be worn by them with their uniforms.

Mine Head and Ballycottin Island Lighthouses, South Coast of Ireland.

THE Corporation for preserving and improving the port of Dublin, hereby give notice, that a lighthouse has been erected on Mine Head, Co. of Waterford, and another Lighthouse on Ballycottin Island, Co. Cork, from which lights will be exhibited on the night of the 1st of June 1851, and which will thereafter be lighted every night from sun-set to sun-rise.

Specification given of the position and appearance of the lights, by Mr. Halpin, Inspector of Lighthouses.

Mine Head Lighthouse is in Lat. 51° 59' 33" N. and Long. 7° 35' 8!' W. and bears

- from Hook Tower Lighthouse, W. b N. distant  $25\frac{1}{2}$  nautic miles.
  - " Coningbeg Rock, W. b N. <sup>3</sup>/<sub>4</sub> N. distant 35<sup>3</sup>/<sub>4</sub> nautic miles.
- " Cable Island (South Point), E. 1/2 N. distant 12 nautic miles.
- ,, Ballycottin Island Lighthouse, E.  $\frac{1}{2}$  N. distant  $17\frac{3}{4}$  nautic miles.
- " Old Head of Kinsale (South Point), E.  $\frac{1}{2}$  N. distant  $42\frac{1}{2}$  nautic miles.

The light will be intermittent, eclipsed once in every minute, appearing of its full brightness during 50 seconds, and obscured during 10 seconds.

The lantern is 285 feet over high water level. The light will be shown from NE. by E.  $\frac{1}{4}$  E. seaward, to W  $\frac{3}{4}$  S. and in clear weather will be visible at the distance of 7 leagues.

Ballycottin Lighthouse is built on the outer island, west side of Ballycottin Bay, in Lat. 51° 49' 30!' N. and Long. 7° 59' W. and bears

- from Mine Head Lighthouse, W. <sup>1</sup>/<sub>2</sub> S. distant 17<sup>3</sup>/<sub>4</sub> nautic miles.
  - " Cable Island (South Point), W. 1 S. distant 6 nautic miles.
  - " Smith's Rock, E.  $\frac{1}{3}$  N. distant  $1\frac{1}{3}$  nautic miles.
  - " Old Head of Kinsale, E.  $\frac{1}{2}$  N. distant 24 $\frac{1}{3}$  nautic miles.

The light will be a flashing light, showing a bright flash once in every 10 seconds, or six flashes in each minute.

The lantern is 195 feet over high water level. The light will be shown from E.  $\frac{1}{2}$  N. seaward, to W.  $\frac{1}{2}$  N. and the flash will be visible at the distance of 6 leagues in clear weather.

The tower is circular, of stone colour. The projecting gallery and blocking under lantern sash, will be coloured red.

The bearings stated are magnetic— $Var. 28\frac{1}{9}^{\circ} W$ . By order,
