**Manchester Improvement Bill.**

NOTICE is hereby given, that application is intended to be made to Parliament, after the Easter recess, for leave to insert in the bill now pending in the House of Commons, "For paving, lighting, cleansing, and otherwise improving the several townships and places in the borough of Manchester, and amending and consolidating the provisions of existing local Acts relating thereto," provisions conferring upon the magistrates of the said borough certain powers with reference to the restoration to the rightful owners of property unlawfully pawned, and awarding amends in cases of frivolous informations, and lessening the share of informers in penalties recovered upon informations

made by them, and mitigation of penalties in certain cases, similar to provisions of the like nature contained in an Act passed in the session of Parliament held in the second and third years of the reign of Her present Majesty, intituled "An Act for regulating the police courts in the metropolis"; also for leave to insert in the said bill provisions for the suppression of juvenile gambling within the said borough.—Dated the tenth day of April, one thousand eight hundred and fifty-one.

NOTICE is hereby given, that application has been made to Parliament, for leave to bring in a Bill in this present session, to empower the Dean and Chapter of the Collegiate Church of St. Peter, Westminster, to build on property belonging to the said Dean and Chapter, situate within the close in the Great Sanctuary, and in the parish of St. Margaret, in the city of Westminster, and also to improve the adjacent property of the said Dean and Chapter, and out of their corporate funds, or out of certain funds payable to the said Dean and Chapter by the Westminster Improvement Commissioners, or out of any funds or monies for the time being standing in the name of the Accountant-General of the High Court of Chancery, or in the names of trustees, and which shall have arisen from or by reason of the sale or enfranchisement of lands and hereditaments belonging to the said Dean and Chapter, or out of any one or more of such funds, or some part thereof, to raise and apply such sums of money as may be necessary to enable them to carry the said undertaking into effect, and for all other purposes connected with the before-mentioned objects; and in the said bill, powers will be applied for to amend such of the several Acts following as it may be necessary or desirable to amend for all or any of the purposes aforesaid; that is to say: Private Acts, 4 and 5 Vict. cap. 25, and 10 and 11 Vict. cap. 28; local and personal Acts, 8 and 9 Vict. cap. 178, 10 and 11 Vict. cap. 131, and 13 and 14 Vict. cap. 102.—Dated 17th April 1851.
