passed in the fifty ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, 'passed in the last session of Parliament, for ' building and promoting the building of additional ' churches in populous parishes,' or under and by virtue of any and every other power or authority whatever in this behalf vested in your Majesty's said Commissioners by the Church Building Acts, and that such proposed district should be named or called ' The District Chapelry of Saint Matthew, Westminster,' with boundaries as hereinafter mentioned, that is to say: on the north, by the parish of Saint Margaret, Westminster; on the west, by a line proceeding southerly from the boundary of Saint Margaret's parish, along the middle of Stratton-ground and the Horseferry-road; on the south, by a line continuing along the middle of the said Horseferry-road easterly, as far as the southern end of Marsham-street; and on the east, by proceeding northerly from the Horseferry-road, up the middle of Marsham-street and Great Smith-street, until it reaches the boundary line of Saint Margaret's parish, as such district chapelry is more particularly delineated on the map or plan hereunto annexed, and is thereon coloured lilac.

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that it also appears to them to be expedient that banns of matrimony should be published, and that marriages, baptisms, and churchings, should be solemnized or performed in the said church of Saint Matthew, that the fees to arise from marriages should be reserved for, and paid over to, the Reverend John Jennings, Master of Arts, the present rector or incumbent of the parish church of the said parish of Saint John, Westminster, during his incumbency thereof; and that upon his avoidance of such parish church, the said fees should belong to the incumbent for the time being of the said church of Saint Matthew; and that the fees to arise from baptisms and churchings should, on the assignment of such district, belong to the minister or incumbent for the time being of the said church of Saint Matthew:

"That the consent of the Right Honourable and Right Reverend Charles James, Bishop of the said diocese of London, has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof he has signed and sealed this representation:

"Your Majesty's said Commissioners therefore humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made, and the recommendations of the said Commissioners in respect of the publication of banns, and the solemnization of marriages, baptisms, and churchings, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased to direct that this Order be forthwith enrolled, pursuant to the said Acts, and registered by the Registrar of the diocese of London.

THEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to "amend and render more effectual an Act passed "in the last session of Parliament, for building and "promoting the building of additional churches in "populous parishes;" and also of the third section of an Act passed in the session of Parliament holden in the second and third years of Her Majesty's reign, intituled, "An Act to make better "provision for the assignment of ecclesiastical dis-"tricts to churches or chapels, augmented by the "Governors of the Bounty of Queen Anne, and "for other purposes;" or under and by virtue of any and every other power or authority contained in the Church Building Acts, duly pre-pared and laid before Her Majesty in Council a representation, bearing date the twenty-first day of July one thousand eight hundred and fifty-one, in the words following, viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that, having taken into consideration all the circumstances of the parish of Saint Andrew, Plymouth, in the county of Devon, and in the diocese of Exeter, it appears to them to be expedient that a particular district should be assigned to the consecrated church of the Holy and Undivided Trinity, situate in the said parish. of Saint Andrew, Plymouth, under and by virtue of the power and authority contained in the sixteenth section of an Act passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act passed in the last session of Parliament, for building and pro-: moting the building of additional churches in populous parishes,' and also in the third section of an Act passed in the session of Parliament holden in the second and third years of your Majesty's reign, intituled 'An Act to make better provision 'for the assignment of ecclesiastical districts to churches or chapels, augmented by the Governors of the Bounty of Queen Anne, and for other pur-' poses,' or under and by virtue of any and every other power or authority in this behalf contained in the Church Building Acts, and that such proposed district should be named 'The District Chapelry of the Holy Trinity, Plymouth,' with boundaries as hereinafter mentioned (that is to say):

"The boundary line commences at the southern end of Zion-street, proceeds along it so far as Notte-street, then turning easterly continues through the middle of Notte-street to High-street, crossing which, it goes through the middle of Vintry-street to Lower Batter-street, and turns southerly through it to the parade, proceeding easterly along the northern side of the parade to the sea, and then skirting the sea to the southern extremity of the Commercial-wharves, leaving which, it proceeds in a westerly and northerly direction up the middle of Commercial-road to Lambhay-hill, and north-westerly along it to Lambhay-green, by which it continues to its junction with the Citadel-road, then westerly along the Citadel-road to the southern end of Zion-
