the allotments in Winkfield, numbered 1363a, 1357, 1356, 1355, and 1354, down to the turn-pike-road leading to Sunninghill, then along the middle of that road easterly as far as the boundary line of the parishes of Sunninghill and Winkfield, along which said boundary it proceeds south-easterly until it reaches the parish of Windlesham, then runs south-westerly along the boundary of the parishes of Winkfield and Windlesham, as far as the parish of Easthampstead, then in a north-easterly and north-westerly direction up the boundary of the parish of Easthampstead, as far as the point of Shepherd's-lane where the boundary of the consolidated chapelry of Bracknell commenced, and as the same is more particularly shown on the plan hereunto annexed, and is thereon coloured pink and green.

"That the consents of the Right Reverend Samuel, Bishop of the said diocese of Oxford, of the Reverend George David Faithfull, of Lower Heyford, in the county of Oxford, Clerk, and the Reverend Abraham Boyle Townsend, of Easthampstead, in the said county of Berks, Clerk, Patrons in trust of the parish church of the said parish of Warfield, and of the Dean and Chapter of the cathedral church of Saint Mary the Virgin, Salisbury, patrons of the parish church of the said parish of Winkfield, have been severally obtained to the formation of the said consolidated chapelry of Bracknell, as required by the Act and section before-mentioned, in testimony whereof the said Samuel, Bishop of Oxford, George David Faithfull, and Abraham Boyle Townsend, have signed and sealed this representation, and the said Dean and Chapter have caused their common or capitular seal to be hereunto affixed.

"Your Majesty's said Commissioners beg leave further to represent to your Majesty that it has been mutually agreed between the said George David Faithfull and Abraham Boyle Townsend, and the said Dean and Chapter, as such respective patrons as aforesaid, testified as aforesaid (with the approbation of your Majesty's said Commissioners, testified as hereinafter mentioned, and of the said Samuel, Bishop of Oxford, testified as aforesaid), that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church of the Holy Trinity, at Bracknell aforesaid, should be vested in, belong to, and, whenever occasion may require, be exercised by, the said Samuel, Bishop of Oxford, and by his successors, Bishops of Oxford, for ever.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty, in your royal wisdom, shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made, and the agreement in respect of the right of presentation and appointment of an incumbent or perpetual curate to serve the said church of the Holy Trinity, at Bracknell, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith enrolled, pursuant to the said Acts, and registered by the Registrar of the diocese of Oxford.
