near Marple Bridge aforesaid, to or near Thornset Gate, in the county of Derby;" or to repeal the said Act, and to grant further, better, and more

effectual powers instead thereof.

And in the said Bill, powers will be applied for to levy and collect tolls upon the said roads; to alter or vary the tolls authorized to be taken by the said Act, or which can now be collected upon the said roads; to confer, vary, or extinguish exemptions from payment of tolls; to alter and regulate the application and expenditure of the money arising from such tolls; and to conter, vary, or extinguish other rights or privileges: and provision is also intended to be made in the said Bill, with reference to the payment of the interest !
