Charles Walker Daniels, formerly of Booth-street, then of Willow-grove, both in Hulme, Manchester, Lancashire, then of Rosamond-street, Chorlton-upon-Medlock, Manchester aforesaid, then of Boston-street, Hulme aforesaid, and late of the Kendal Castle, Stretford New-road, Hulme aforesaid, formerly Warehouseman, afterwards Warehouseman and Retail Dealer in Ale, and latterly Retail Dealer in Ale only.

Thomas Moss, formerly of Beam-street, afterwards of Pillory-street, Boot Maker, then of the Vine Tavern, Hospital-street, Licensed Victualler and Boot Maker, then of Beam-street aforesaid, all in Nantwich, Cheshire, and late of No. 2, Blair-street, Porter-street, Manchester, Lancashire, Boot Maker.
