Disafforestation.

OTICE is hereby given, that application is intended to be made to Parliament in the next session, for an Act to disafforest the Forest of Whittlewood otherwise Whittlebury, in the counties of Northampton, Oxford, and Buckingham, or in some or one of the said counties; to abolish all forestal offices in or over the said forest; to allot to Her Majesty, in severalty, a part of the said forest, in compensation for her forestal and other rights in and over the said forest; to allot to the Warden, Master Forester, Ranger, or Master of the Game of the said forest, in severalty, other part of the same forest, in compensation for all his rights as such Warden, Master Forester, Ranger, or Master of the Game of the said forest; to make compensation to the several parties entitled to any other forestal offices in or over the said forest; to
