Bermondsey Regulation Act, 1853.

Repeal, Amendment, or Consolidation of Existing Local Acts relating to the parish of Bermondsey; Provisions in lieu thereof for the better regulation of such parish and its matters; Powers to levy rates; and for other purposes.

OTICE is hereby given, that application is intended to be made to Parliament in the present session, for an Act to repeal, either wholly or in part, or to alter, amend, or consolidate the following Acts of Parliament, or some or one of them, that is to say, an Act passed in the 31st year of King George the 2nd, intituled "An Act for ascertaining and collecting the Poor's Rates, and for better regulating the Poor in the parish of St. Mary Magdalen, Bermondsey, in the county of Surrey;" an Act passed in the 31st year of King George the 3rd, intituled "An Act for amending and enlarging the Powers of and rendering more effectual an Act made in the 31st year of the reign of His late Majesty King George the 2nd, intituled 'An Act for ascertaining and collecting the Poor's Rates, and for better regulating the Poor in the parish of St. Mary Magdalen, Bermondsey, in the county of Surrey, and for other the purposes therein mentioned;" an Act passed in the 49th year of King George the 3rd, initialed "An Act for rendering more effectual two Acts passed for the better regulating the poor in the parish of St. Mary Magdalen, Bermondsey, in the county of Surrey, for enclosing the churchyard thereof, and for other purposes therein mentioned relating thereto;" an Act passed in the 7th year of King George the 4th, intituled "An Act for building a crypt and tower to the additional church erecting in the parish of St. Mary Magdalen, Bermondsey, in the county of Surrey, for vesting the said church and the burial ground thereof in trustees, and for other purposes relating thereto;" an Act (private and personal) passed in the 1st year of King William the 4th, and being chapter 22, and being an Act for raising money to defray expenses incurred under the above last-mentioned Act; an Act passed in the 7th year of the reign of Her present Majesty Queen Victoria, intituled "An Act for more effectually repairing certain roads in the parishes of Bermondsey, Rotherhithe, and St. Paul and St. Nicholas, Deptford, and for making several new roads connected therewith, all in the counties of Surrey and Kent." An Act passed in the session of parliament holden in the 8th and 9th years of the reign of her said present Majesty, intituled "An Act for more effectually paving, cleansing, lighting, and otherwise improving the parish of Saint Mary Magdalen, Bernondsey, in the county of Surrey." And by the said in-tended Act it is proposed to make other provisions in lieu of those in the said several Acts, or some of them contained, for the better management and regulation of the poor of the said parish of St. Mary Magdalen, Bermondsey; for the better ascertaining, assessing, collecting, and applying the poors rates, church rates, highway rates, police rates, and all other rates chargeable or assessable within the said parish, or any part thereof; for the better management and control of the churchyard of the church of St. Mary Magdalen, and of the church or chapel of St. James, and the churchyard thereof, all in the said parish, and if necessary, to prohibit further interments in such churches and churchyards respectively; to make better provision for the control and regulation of the charities and schools of the said parish of St. Mary Magdalen, Bermondsey, all or some of them. To make better provision for paving, cleansing, lighting, and otherwise improving the roads, streets, and other public places within the said parish of St. Mary Magda-len, Bermondsey. To invest the management of ney, Saint Swithin London Stone, and Saint Mary No. 21,926

the Public Baths and Wash-houses of the said parish in the commissioners or trustees to be appointed under the said intended Act; to exempt the said parish of St. Mary Magdalen, Bermondsey, from an Act of Parliament passed in the 58th year of King George the 3rd, intituled "An Act for the Regulation of Parish Vestries," and to make better provision for the meeting in public of the inhabitants and others of the same parish. And by the said intended Act it is proposed to nominate and appoint certain persons to be commissioners or trustees for carrying into effect the objects and purposes thereof : and to take power to purchase, by compulsion or otherwise, lands, houses, and buildings required for the purposes of the said intended Act: also to levy tolls, rates, rents, and duties, and to confer exemptions from the payment of such tolls, rates, rents, and duties, and to vary or extinguish all rights or privileges, and to repeal, alter, or amend all or any Acts of Parliament which can in any manner impede or interfere with the due execution of the said intended Act, and the carrying out the several objects proposed to be authorized thereby, and to take all necessary powers for carrying the said intended Act into complete execution and effect

And notice is hereby further given, that a copy of the proposed Bill will be deposited in the Private Bill Office of the House of Commons on or before the 31st day of December next.

Great London Drainage Bill.

(Powers to incorporate company for relieving the river Thames from Impurities by draining the Metropolis by tunnel sewers; powers to collect the contents of sewers and to dispose of the same for agricultural purposes).

OTICE is hereby given, that application will be made to Parliament in the next session, for leave to bring in one or more bills to incorporate a company, with power to make, construct, and maintain lines of sewers, drains, and culverts, and other works on the north and also on the south sides of the river Thames, for intercepting and collecting the sewage from all existing sewers and drainage which are now emptied into the river Thames, and from all drains and sewers hereafter to constructed within the limit of the said bill or bills, and for acquiring and collecting such sewage, and conveying the same into receptacles and depositories to be constructed for that purpose; and it is intended that the lines of sewers and drains to be constructed for the said works on the north side of the said river Thames, shall commence at or near Parliament street, in the parish of Saint Margaret Westminster, and shall be made in, under, and through the lands, streets, roads, ways, passages, and other places in the several parishes, townships, and extra parochial places following, or some of them, that is to say, Saint: Margaret Westminster, the Precinct of Whitehall, the Verge of the Palace, Saint Martin-in-the-Fields, Saint Paul Covent Garden, Saint Mary-le-Strand, the Precincts of the Savoy, Saint Clement Danes, in the county of Middlesex; Saint Dunstan in the West, Trinity church Gough-square, Saint Bridget or Saint Bride Whitefriars, Bridewell Precinct, Saint Martin Ludgate, Saint Mary Magdalen Old Change, and Saint Gregory by Saint Paul's, Saint Augustin or Saint Austin Old Change, and Saint Faith under Saint Paul's, the Precincts of Saint Paul's, Saint Nicholas Coleabbey; Saint Margaret Moses, Saint Mildred Bread street, Allhallows Bread street, and Saint John the Evangelist, Saint Mary Aldermary, Saint Anthony
