NOTICE is hereby given, that His Royal Highness Prince Albert will, by the desire of Her Majesty, hold a Levee at St. James's-Palace, on behalf of Her Majesty, on Wednesday, 9th March next, at two o'clock.

It is Her Majesty's pleasure that presentations to His Royal Highness at the Levee shall be considered equivalent to presentation to the Queen.

Addresses to the Queen may either be forwarded to Her Majesty through the Secretary of State for the Home Department, or may be reserved until Her Majesty shall hold a Levee.

REGULATIONS TO BE OBSERVED AT THE LEVEE AT St. James's-Palace.

The Noblemen and Gentlemen, who purpose to attend the Levee, at St. James's-Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Presence-chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name.

Those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be delivered at the Lord Chamberlain's Office, before twelve o'clock, on the Monday previous to the Levee, in order that they may be submitted for approbation; it being Her Majesty's command, that no presentation shall be made at the Levee but in conformity with the above regulations.

It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them.

The state apartments will not be open for the reception of Company coming to Court, until half-past one o'clock.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in

the eleventh and twelfth years of Her Majesty's reign, intituled "An Act to carry into effect the "arrangements of the Ecclesiastical Commis-"sioners for England for making better provision for the cure of souls in the parish of Wolver-"hampton, in the county of Stafford, and diocese of Lichfield," duly prepared and laid before Her Majesty in Council a scheme, bearing date the tenth day of February, in the year one thousand eight hundred and fifty-three, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the eleventh and twelfth years of your Majesty's reign, intituled An Act to carry into effect the arrangements of the Ecclesiastical Commissioners for England for making better provision for the cure of souls in the parish of Wolverhampton, in the county of Stafford, and diocese of Lichfield,' have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing us to contribute towards the reparation of the church of Saint Peter's, Wolverhampton:

"Whereas it is by the said Act enacted, that it shall and may be lawful to and for us, under the authority therein mentioned (that is to say, a scheme prepared by us and ratified by an Order of your Majesty in Council), to allow and contribute at any time or times after the passing of the same Act, out of the common fund, vested in us by the Acts therein recited, such sum or sums of money as shall be deemed by us reasonable and necessary towards the costs, charges, and expenses to be incurred in the necessary reparation of the said church of Saint Peter's, Wolverhampton:

"And whereas it has been made to appear to us by the estimate of a competent architect, that in order to complete the necessary reparation of the said church, according to certain plans and specifications, prepared after a careful survey of the said church, and approved by us, the sum of six thousand pounds, or thereabouts, will be required:

required:

"And whereas it has been resolved, at a public meeting of the inhabitants of the town of Wolverhampton and others, to raise a subscription towards carrying into effect such reparation of the said church, as aforesaid:

"Now, therefore, we humbly recommend and propose, that we be authorized and empowered to contribute and pay out of the said common fund as aforesaid, to such persons at such times and in such manner as shall be deemed by us to be most

expedient, such sum or sums of money not exceeding in the whole the sum of three, thousand pounds, as together with any other sum or sums of equal amount therewith, which may be so subscribed as aforesaid, shall be necessary for effecting the reparation of the said church, according to such plans and specifications as aforesaid:

"And we further recommend and propose, that nothing therein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Lichfield.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to "amend and render more effectual an Act passed "in the last session of Parliament for building and promoting the building of additional "churches in populous parishes," and of the third section of an Act, passed in the session of Parliament holden in the second and third years of Her Majesty's reign, intituled "An Act to "make better provision for the assignment of ecclesiastical districts to churches or chapels augmented by the Governors of the Bounty of Queen Anne, and for other purposes," or under and by virtue of any and every other power or authority contained in the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the fourteenth day of February, one thousand eight hundred and fifty-three, in the words following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that having taken into consideration all the circumstances of the parish of Bolton-le-Moors, in the county of Lancaster, and in the diocese of Manchester, it appears to them to be expedient that a particular district should be assigned to the consecrated chapel situate at Bradshaw, in the said parish of Bolton-le-Moors, under and by virtue of the power or authority contained in the sixteenth section of an Act passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to 'amend and render more effectual an Act, passed in the last session of Parliament for building 'and promoting the building of additional 'churches in populous parishes,' and in the

third section of an Act, passed in the session of Parliament holden in the second and third years of your Majesty's reign, intituled 'An Act to make better provision for the assignment of ecclesiastical districts to churches or chapels augmented by the Governors of the Bounty of Queen Anne, and for other purposes,' or under and by virtue of any and every other power or authority in this behalf contained in the Church Building Acts, and that such proposed district should comprise the whole of the township of Bradshaw and certain portions of the townships of Turton and Harwood, and that it should be called 'The District Chapelry of Bradshaw,' and that the boundaries thereof should be those hereinafter mentioned; that is to say: to commence near Walk Mill, at the point where the townships of Harwood, Turton and Tong unite, and to pro-ceed thence, in an easterly direction, along the footpath or bridle-way, which passes by a farmhouse situated on the school land called Bottom of the Moor, to Longsight-lane, and thence, northeasterly, up the centre of Longsight-lane, to the Three Lane Ends, at the Wesleyan school, thence, westerly along the centre of the Harwood-road, to the Three Lane Ends at Lee Gate Hillock, thence, along the centre of the Raikes-road, easterly, to the point, near Old Smithy, where the townships of Bradshaw, Harwood, and Tottington Lower End unite, thence, north-westerly, westerly, and southerly, along the boundary of the township of Bradshaw to where the rivulet from the well at Ousel Nest, in Turton township, falls into Bradshaw brook, thence, westerly, up and along the said rivulet to the said well, thence, along the footpath from the said well to the Turton-road, and along the centre of the said Turton-road, southerly, to the point where it is met by Haydock-lane, thence, westerly, along the centre of Haydock-lane, as far as the western side of Haydock's Farm Buildings, and from such point, in a straight line, in a southerly direction, to the southeasterly side of the premises called the Volunteer Inn, in the Bury-road, and, entering that road, the boundary line then proceeds, south-easterly, along the same as far as Bertinshaw-road, and then proceeds, south-westerly, along the middle of the latter road, as far as the river Eagley, (such line of boundary, from Haydock's Farm Buildings to the river Eagley, being the boundary line of Walmsley Chapelry District,) thence, along the said river Eagley, to the point where the town-ships of Sharples, Turton, and Tong unite, thence, easterly, along the boundary of the townships of Turton and Tong, to the point first mentioned, near Walk Mill, where the townships of Harwood, Turton, and Tong unite, as such District Chapelry of Bradshaw is more particularly delineated on the map or plan hereunto annexed, and thereon coloured pink.

"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that baptisms, churchings, and burials should be solemnized or performed in the said chapel, and that the fees to arise therefrom should be paid and belong to the incumbent of such chapel for the time being.

"That the consent of the Right Reverend James Prince, Bishop of the said diocese of Manchester, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representa-

"Your Majesty's said Commissioners, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated chapel at Bradshaw, in the parish of Bolton-le-Moors, be accordingly made, and the recommendations of the said Commissioners in respect of the solemnization of baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Manchester.
