By virtue of an Act, passed in the 13th year of the Reign of Her present Majesty, intituled "An Act for consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other provisions in regard to the consolidated Offices."

RICHARD MAYNE, one of the Commissioners of Police of the Metropolis, being appointed by one of Her Majesty's Principal Secretaries of State to do all things by the said Act authorized to be done by the Commissioners of Police of the Metropolis, do hereby appoint standings for hackney carriages at the several places hereinafter mentioned, for such number of carriages at each standing as is specified, and within the boundaries set forth for each standing, provided that no hackney carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.

Five Carriages.

To commence from Second Yard Gate from Railway Yard, along the west side of the road to the south end of the wall enclosing the premises of the Royal Naval School.

Four Carriages.

To commence 30 feet from the South Entrance to the Railway Station at Wandsworth, along the wooden fence on the east side of North-street to the first Gas Lamp.

Twenty-six Carriages.

To commence 10 feet west from the Iron Pump, along the footway on the south side, to opposite Stanhope-place.

Twelve Carriages.

To commence opposite No. 200, in centre of street, to No. 217, keeping clear of Nos. 208, 209, and 210.

Six Carriages.

To commence 66 feet from Buckingham Gate, extending 144 feet towards Her Majesty's Stationery Office, by side of curb stone, in James's-street, Buckingham Gate.

To commence opposite the west corner of Sackville-street, in centre of Piccadilly, keeping clear of the Albany Court-yard, to within 25 feet of the east corner of Duke-street.
