A T the Court at Osborne-House, Isle of Wight, the 19th day of August, 1853,

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

W HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the ninth section of an Act, passed in the session of Parliament held in the eighth and ninth years of Her Majesty's reign, intituled "An Act for the "further amendment of the Church Building Acts," or under and by virtue of any and every other power or authority vested in them by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the thirty-first day of July last, in the words following, viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent, that having taken into consideration all the circumstances of the parishes of Watford and of Saint Stephen, in the county of Hertford, and in the diocese of Rochester, it appears to them to be expedient to unite and consolidate certain contiguous portions of the said two parishes, and to form the same into one consolidated chapelry for all ecclesiastical purposes, for the consecrated church of All Saints, situate at Leavesden, in the said parish of Watford, under and by virtue of the power or authority for this purpose contained in the ninth section of an Act of Parliament, passed in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further amendment of the Church Building further amendment of the Church Building Acts,' and that such proposed consolidated chapelry should be named or called 'the Consolidated Chapelry of 'Leavesden,' and that the boundaries thereof should be those hereinafter mentioned; that is to say: commencing at a lane in the said parish of Watford leading out of the Leavesden Greenroad, continuing along the said lane for the space of seventy-three yards or thereabouts, until it reaches Rushey Croft, No. 855, on the plan to the Tithe Commutation Award for the said parish of Watford, and continues along the said lane adjoining Rushey Croft and Long Spring, until it comes to the western corner of Long Spring; then leaving the said lane and turning south-east, con-tinues along the south-western boundary of Long Spring, being No. 845 on the said plan, until it reaches the turnpike-road leading from Rickmansworth to Saint Albans; then turning to the north,

continues along the west side of the said read until it arrives at a lane leading south-east from the said road, and continues along the north-eastern boundary of the said lane until it reaches the River Colne; then turning north-eastward, continues along the bank of the River Colne until it joins the portion of the said consolidated chapelry belonging to Saint Stephen's parish; and then continuing along the bank of the River Colne until it comes to a peec of land No. 757 in the Tithe Commutation Award for the parish of Saint Stephen's; and following the river to the corner of the field numbered 699 on the plan of the said award, crosses the said field to the corner of No. 750; and then following the boundary of Bricket Wood Common to the gate at the north corner, crosses the Black Boy Wood to the Black Boy Turnpike, on the Watford-road, from the Turnpike on the high-road from Rickmansworth and Watford to Saint Albans, going south-westerly along the southern side of the said road, until it comes to the boundary of the parish of Watford, at Waterdale; then going north-west along the boundary of the said parish of Watford, until it comes to the parish of Abbots Langley; then turning westward, continues along the boundary of the said parish of Watford, until it comes to the point in the Leavesden Green-road, where the boundary of the said consolidated chapelry of Leavesden commenced, and as the same is more particularly delineated on the map or plan hereunto annexed, and thereon coloured red and blue.

"That the consents of the Right Reverend George, Bishop of the said diocese of Rochester, of the Right Honourable Arthur Algernon Earl of Essex, Patron (as tenant for life of, but not for the next presentation to) the parish church of the said parish of Watford, of Richard James, of Ash Lodge, Saint John's Wood, in the county of Middlesex, Esquire, Patron (for the next presentation only of or to the said parish church of Watford), and of the Reverend Marcus Richard Southwell, Master of Arts, patron (in his own right) of the parish church of the said parish of Saint Stephen, have been severally obtained to the formation of the said consolidated chapelry of Leavesden, as required by the Act and section hereinbefore mentioned, in testimony whereof they have severally signed and sealed this representation.

"Your Majesty's said Commissioners beg leave further to represent, that it has been mutually agreed between the said Arthur Algernon Earl of Essex, Richard James and Marcus Richard Southwell, as such respective patrons as aforesaid

your Majesty's said Commissioners, testified as hereinafter mentioned, and of the said George, Bishop of Rochester, testified as aforesaid), that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church called All Saints Church, at Leavesden aforesaid, should, for the first turn or right of presentation and appointment that may arise, be vested in, belong to, and, whenever occasion may require, be exercised by Arthur Currie, of the Elms, in the said county of Hertford, Esquire, and that every subsequent presentation and appointment should be vested in, belong to, and, whenever occasion may require, be exercised by the vicar for the time being, of the said parish church of Watford.

"Your Majesty's said Commissioners therefore humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto, as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed formation into one consolidated chapelry for the consecrated church of All Saints, at Leavesden, in the parish of Watford, be accordingly made, and that the agreement in the said representation mentioned and contained in respect of the right of presentation and appointment of an incumbent or perpetual curate to serve the said church be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese C. C. Greville. of Rochester.
