The QUEEN's Most Excellent in Majesty Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled, "An Act to carry into effect, with cer"tain modifications, the fourth report of the Com"missioners of Ecclesiastical Duties and Revenues," and of another Act, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled "An Act to explain "and amend two several Acts relating to the "Ecclesiastical Commissioners for England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the ninth day of June, in the year one thousand eight hundred and fifty-three, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled 'An Act' to carry into effect, with certain modifications, 'the Fourth Report of the Commissioners of 'Ecclesiastical Dutics and Revenues,' and of another Act, passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled 'An Act to explain and amend 'two several Acts relating to the Ecclesiastical 'Commissioners for England,' have prepared, and now humbly lay before your Majesty in Council, the following scheme for transferring the patronage of the church of the district chapelry of the Holy Trinity, Vauxhall-bridge-road, in the county of Middlesex, and in the diocese of London.

"Whereas it is by the said Act enacted, with an especial view to the better care of populous parishes, that arrangements may from time to time be made, by the authority therein provided (that is to say, by a scheme prepared by us, and ratified by a duly gazetted Order of your Majesty in Council), for improving the value, or making a better provision for the spiritual duties, of illendowed parishes or districts, by means of such alterations in the exercise of patronage as may be agreed upon by patrons, with the consent of the Rishop.

"And whereas it is by the said secondly recited Act enacted that such arrangements may be made,

notwithstanding such patronage shall be vested in, or belong to, any ecclesiastical corporation, aggregate or sole.

"And whereas the said district chapelry of the Holy Trinity, Vauxhall-bridge-road, contains a large population, and the church thereof is not adequately endowed.

"And whereas the patronage of, or right of nomination of a minister to, the said church is vested in the Reverend William Harry Edward Bentinck, Clerk, Canon, and Archdeacon of the collegiate church of Saint Peter's, Westminster, and Elizabeth Frances, his wife, and their assigns, during their joint lives, and, after the death of either of them, in the survivor and his or her assigns during his or her life, and after the decease of the survivor then in the following trustees, videlicit: the Dean of the said collegiate church of Saint Peter's Westminster, the Rector of Saint John the Evangelist in Westminster, and the Rector of Saint Margaret's Westminster, and their respective successors for the time being, for ever

"And it has been agreed by the said patrons to transfer such patronage and right of nomination to the Dean and Chapter of the said collegiate church of Saint Peter's Westminster, with a view to the augmentation of the endowment of the said church by the said Dean and Chapter with a yearly rent charge of two hundred and fifty pounds, to be issuing out of, and secured upon, certain premises now forming part of their capitular estates; and the said Dean and Chapter have agreed to make such augmentation accordingly, and in token of such agreement have hereunto affixed their corporate seal.

"Now, therefore, we humbly recommend and propose, with the consent of the Right Honourable and Right Reverend Charles James, Bishop of London, and of the said William Harry Edward Bentinek, and Elizabeth Frances his wife, the Right Honourable and Reverend Lord John Thynne, Sub-dean of the said collegiate church, acting for the Dean thereof by virtue of your Majesty's warrant, the Reverend John Jennings, Rector of Saint John the Evangelist, in Westminster, and the Reverend William Cureton, Rector of Saint Margaret's, Westminster, in testimony whereof they have respectively signed and sealed this scheme, that, with a view to effecting such augmentation as aforesaid, the patronage of, and right of nomination of, a Minister to the said church of the district chapelry of the Holy Trinity, Vauxhall-bridge-road, shall, upon and from the
